THE DEPARTMENT

Under the Business, Consumer Services, and Housing Agency, the Department of Housing and Community Development (HCD) is California's principal housing agency. The Department performs three primary functions:

- Administers State and federal housing finance, housing rehabilitation, and economic development programs.
- Analyzes, enforces, and participates in the development of building codes, manufactured housing standards, and mobilehome park regulations.
- Promotes the development of housing for all Californians, including analyzing, advising and assisting in implementing state and local government housing related laws, policies, and programs and administering State housing grant programs to local governments to increase the supply of housing and encourage vibrant community development.

HCD administers \$3.75 billion in affordable housing funding under Propositions 1C and 46, as well as more than \$80 million each year in federal CDBG and HOME funds. Visit www.hcd.ca.gov/fa/ for more information.

The Department also reviews the housing element portions of each of the state's 535 cities and counties general plans. By encouraging local governments to allow for the development of a wide variety of housing to meet the state's housing needs, the Department ensures that more housing will be built for California's families.

THE POSITION

The HCDR II classification is the fully experienced professional level, performing responsible and technically difficult work under general direction. Typical duties include:

- Evaluating funding applications for affordable housing, emergency shelter, and community and economic development projects.
- Providing technical assistance to for-profit and non-profit developers, and local public agencies.
- Working with local governments and regional planning bodies on housing and land use plans and programs.
- Researching local housing needs.
- Developing policies and legislation to preserve affordable housing, remove barriers to new housing, and more.
