## Guidelines for Registration of a Manufactured Home/Mobilehome on Yearly Registration Renewal Fee and Tax Waiver Program

Effective January 1, 2017 through December 31, 2019, owners of manufactured homes and mobilehomes who are currently not the registered owner(s) in the Department of Housing and Community Development's (HCD) records are eligible to apply to register their homes with HCD and obtain waivers from certain fees and back taxes.

These guidelines are specifically for unregistered homes that have an HCD decal number that begins with the letter "A" and are subject to in lieu taxation (ILT).

In order to apply for the fee and tax waiver and to register the home, the person asserting an ownership interest (the applicant) shall file an application to register as the new owner, pay any required fees, and submit the following:

Do o	ocumentation demonstrating chain of ownership, which includes the following:  An authentic HCD Certificate of Title (not a copy) signed by all owners (Registered Owner or Legal Owner) printed on the title. The applicant shall complete the "New Owner Information" area and sign where appropriate.	
0	If the original last-issued HCD Certificate of Title is unavailable, an <u>Application for Duplicate Certificate of Title Form (HCD RT 480.4)</u> can be completed, with releasing signatures from all owners (Registered Owner or Legal Owner) on record with HCD. The applicant shall complete the "New Owner Information" area and sign where appropriate.	
0	Use of the bond process: if the applicant is unable to obtain the release from the registered owner(s), legal owner(s) or junior lienholder(s), which is not a financial institution, the applicant must comply with the information and instructions in form <a href="https://example.com/hcb/rt/480.0">HCD RT 480.0</a> — Bond Requirements and submit the required form <a href="https://example.com/hcb/rt/476.61">HCD RT 476.61</a> — Statement of Facts - Bond.	
The authentic registered owner's Registration Card (not a copy) or, if unavailable, an <u>Application for Duplicate Registration Card Form (HCD RT 481.2)</u> completed.		
Multi-Purpose Transfer Form (HCD RT 476.6G) with appropriate sections completed and signed by the applicant(s).		
this	<u>HCD RT 476.4</u> — Certification of Retail Value and Purchase Price completed by the applicant. Page 2 of this form may be submitted to HCD to obtain the retail value. Use Tax will be paid on the lesser of the retail value of the home or purchase price.
