*Draft Substantial Amendment to the 2008/2009 Annual Plan of the
State of California's Five-Year Consolidated Plan (2005-2010)*

The State of California, Department of Housing and Community Development (Department), is soliciting public review and comment to the Draft Substantial Amendment of the 2008/2009 Annual Plan for the State of California's Consolidated Plan FY 2005-2010. This amendment is a result of the newly established Community Development Block Grant Recovery Program (CDBG-R), Title XII of Division A of the American Recovery and Reinvestment Act of 2009.

The Substantial Amendment will be submitted to the U.S. Department of Housing and Urban Development (HUD) for approval. Upon HUD's approval the State of California will administer approximately \$10.6 million in federal funds for CDBG eligible activities. The State CDBG-R will be administered under the Federal American Recovery and Reinvestment Act of 2009. The public review period for these documents is 7 days, from June 18, 2009 through June 25, 2009. The Department must receive all comments on these documents by 4 p.m. June 25, 2009.
