SUBJECT: Voucher Number Allocations—Update

This memorandum from the Department of Housing and Community Development (Department) represents an update to Management Memorandum 7-06 issued on December 12, 2007. This update provides voucher numbers for the economic development areas not included in the previous memorandum. The economic development areas not previously included consist of the enterprise zones awarded since January 2008, the local agency military base recovery areas (LAMBRAs), the manufacturing enhancement areas (MEAs) and the Targeted Tax Area (TTA).

Requirement for Voucher Numbers

The Department requires all economic development areas to sequentially identify vouchers issued using numbers allocated by the Department. See Attachment A for a list of the designated ranges for each area. Please refer to Memorandum 7-06 for an overview on how to use the voucher numbers.

All economic development areas that are receiving their voucher numbers for the first time should begin using them immediately. If practical, these areas should retroactively assign these numbers to any vouchers issued since January 1, 2008. At the end of the calendar year, the Department will request from each economic development area a summary of the voucher numbers assigned.
