INFORMATION AND INSTRUCTIONS:

1. For a MANUFACTURED HOME dealership, each person participating in the direction, control or management activities of the sales operation must have completed the APPROPRIATE clock hours of approved Continuing Education Courses as required in Health and Safety Section 18056.2 and Title 25, California Code of Regulations (25CCR), Division 1, Chapter 4, Subchapter 2, Section 5306 PRIOR TO EXPIRATION of the license. Should any participating person of the dealership FAIL TO COMPLETE the required clock hours prior to expiration of the license, the dealer license will not be eligible for renewal.

For a MANUFACTURED HOME salesperson, you must have completed the APPROPRIATE clock hours of approved Continuing Education Courses PRIOR TO EXPIRATION of the license as required in Health and Safety Code Section 18056.2 and 25CCR Section 5306. FAILURE TO COMPLETE the required clock hours prior to the expiration date will result in expiration of the license.

COMMERCIAL MODULAR DEALERS and SALESPERSONS issued licenses exclusively for the sale of commercial modulars are exempt from Continuing Education requirements.

- 2. Holders of both a manufactured home dealer and salesperson license may apply the same Continuing Education clock hour credits toward the renewal of both licenses, provided the credits were earned within the respective licensure terms.
- 3. Submit this Certification of Clock Hour Earnings (HCD OL 137), along with your renewal application.

NOTE: Participating persons of a dealership need only submit this certification with the application to renew the main location.
