On behalf of the United Auburn Indian Community, thank you for your letter requesting information on when to consult with Tribes for types of single-family housing unit projects. I reviewed the list of the types of projects and believe the only one that would require consultation would be for Site work to meet CA Wildland Urban Interface standards for homes in high risk areas. That is assuming that the "site work" may include tree and brush removal, or other ground disturbing activity in areas that are not for habitation but for fire safety. The Preservation Department would check our files to determine if there are any site of cultural or religious significance to the Tribe in the project area and provide recommendations on avoidance or minimization.



Hi Joseph,

Thank you for contacting the San Manuel Band of Mission Indians (SMBMI) regarding the proposed efforts related to disaster recovery and the request for insights concerning potential consultation. For your knowledge, the only County on your list that overlaps with Serrano ancestral territory is Los Angeles, and even then it is only the Antelope Valley and a portion of the Angeles National Forest. Based on the list of activity types, it is likely SMBMI will not elect to consult on many projects related to disaster relief. However, a good rule of thumb that your agency could use is to reach out concerning any effort that will result in ground-disturbing activity, to exclude efforts that will be focused on rebuilding within a previously built-out footprint (i.e. rebuilding a burned down home, demolition/rebuild, etc.). All that being said, our office is highly responsive, and we will be more than happy to review anything you send our way.

The California Department of Housing and Community Development (HCD) is serving as the lead and responsible agency for administering the Community Development Block Grant – Disaster Recovery (CDBG-DR) from the U.S. Department of Housing and Urban Development to support long-term recovery efforts following the federally declared disasters during late 2017. The 2017 CDBG-DR program will provide grants to owner-occupied homeowners to rehabilitate or reconstruct homes damaged or destroyed by the wildfires, flooding, mudflows and/or debris flow disasters in 2017 (DR-4344 and DR-4353). Under the CDBG-DR funding umbrella, the HCD has established an Owner-Occupied Rehabilitation and Reconstruction Program (the "Program") to support long-term recovery efforts and address unmet housing needs in areas impacted by the 2017 disasters. The program is designed to ensure that the housing needs of very-low, low- and moderate-income households and vulnerable populations are addressed to the greatest extent feasible.

The Program will allow affected residents to apply directly to the State for gap financing grants to repair or reconstruct their single-family homes. Projects under the program are expected to involve repair/rehabilitation or reconstruction of single-family dwellings, such as stick built, modular, or manufactured housing unit. Reconstruction has been defined by the Program as the rebuilding of a structure on the same site in substantially the same footprint and manner. A reconstructed property must not increase the number of dwellings on site, although the number of rooms may increase or decrease.

In accordance with 24 CFR Part 58, HCD is facilitating the federally-required environmental reviews for the Program in the following 12 counties:

- 1. Butte
- 2. Lake
- 3. Los Angeles
- 4. Mendocino
- 5. Napa
- 6. Nevada
- 7. Orange
- 8. San Diego
- 9. Santa Barbara

10. Sonoma 11. Ventura 12. Yuba.

As specified in the State of California's, March 19, 2019 *Action Plan for Disaster Recovery*, the best currently available data suggests that approximately 400 homeowners may seek funding through this program. Individual project sites will be reviewed as part of Tier 2 once those sites are identified.

The proposed projects will be occurring in 12 counties and could potentially be located within your tribal territory. HCD seeks input from your Tribe on the need for consultation concerning the following types of single-family housing unit projects:

- 1. Replacement of damaged or destroyed necessary equipment, such as HVAC units;
- 2. Repairs to disaster-damaged primary structures;
- 3. Reconstruction of the disaster-damaged primary structure;
- 4. Upgrades required to meet current building code (including the 2019 Building Energy Efficiency Standards, where applicable);
- 5. Site work to meet CA Wildland Urban Interface standards for homes in high risk areas;
- 6. Addition of handicap accessibility features (if applicable); and,
- 7. Lead-based paint and asbestos abatement (if applicable).

Please let us know if any of these project types would require consultation with your Tribe. If consultation is required, it would be helpful if you could identify which specific conditions would trigger the need for consultation.

HCD is dedicated to providing disaster assistance to people in need of single-family housing as a result of the 2017 disasters as soon as possible.
