Executive Summary:

The 2013 Rim Fire destroyed 257,314 acres of land in Tuolumne County and ranks as the third largest wildfire in State history. The fire burned for over two months through large portions of the Stanislaus National Forest, threatening surrounding communities and damaging the critical watershed for local communities, the San Joaquin Valley, and San Francisco (City/County). Unfortunately, the Rim Fire is not an isolated incident. In 2016, a total of 2,986 fires consumed 564,835 California acres. Despite a record snowfall, 2,134 fires have consumed 22,817 acres in California during the period between January 1 and June 18, 2017.

The Rim Fire's direct emergency response cost was \$127 million and estimates of environmental damage range up to \$736 million. In September 2015, the Valley and Butte Fires burned over 145,000 acres, destroyed 2,728 structures and resulted in 7 deaths. California's prolonged severe drought and related epidemic tree mortality magnifies risk, coupled with 2017's above average rain and snow fall levels which creates fuel loading grasses and vegetation that can readily be ignited in summer thunderstorms.

Fires have serious consequences for local communities, including public health impacts, property damage, and economic disruption. They also threaten the backbone watersheds of the State's water system; sixty percent of the State's water supply originates in California's Sierra Nevada region.

The Community and Watershed Resilience Program (CWRP) provides an innovative, revenue-generating, scalable, and replicable model for similar regions throughout California and the western United States. Developed in partnership with federal and local government agencies, community organizations, and private business, the CWRP is built around partnerships and practices designed to overcome the financial and institutional barriers to sustainable, healthy forests and watersheds. The CWRP will also facilitate the transition to a sustainable forest economy in our rural communities.

The State of California's Community and Watershed Health Resilience Program is composed of activities in three integrated pillars: 1). Forest and Watershed Health Activities include forest thinning, biomass removal, restoration, and reforestation within the Rim Fire burn area, designed to improve forest and watershed health and resilience against disturbances; 2). The Integrated Biomass and Wood Products Facility will provide clean power, cooling and heating, and a wood products facility to utilize biomass material removed from the impacted disaster area; and 3). A Community Resilience Center, designed to increase community resilience by providing year round services, including education and job training to support forest and watershed work and the biomass facility. This facility will be a model for serving rural communities.

HUD granted a limited waiver modifyig 42 U.S.C. 5305(c)(2)(A)(i) to the extent necessary to permit the state to use a percentage of not less than 38 percent to qualify activities under the low-and moderate-income area benefit national objective in the August 7, 2017 Federal Register Notice. The demographics of the declared disaster (MID URN) area, includes a high population of seasonal residents and retirees. The area lacks access to education and jobs, 14.5% of the county resident

s live in poverty, 12% have not completed high school and 51% of the county households are over age 60. HUD has not officially responded to the State's waiver request. If, based on the results of the Biomass Utilization Facility feasibility study, it is determined that using the Low-Moderate Jobs National Objective is the best approach, no LMI waiver would be necessary for the Biomass Utilization Facility funding.



MID-URN Areas:

MID-URN AREAS: The Target Area includes the Rim Fire burn and evacuation and evacuation waring areas (Rim Fire Burn Scar, Evacuation Areas) in Census Tracts 06109002200, 06109004100, 06109003100, 06109003200, 06109004200. The State is incorporating resilience and replicability for forest and watershed health activities. This includes thinning, creating fuel breaks, reforestation, biomass removal, rangeland improvements and noxious weed treatments to reestablish carbon storage in living trees, help prevent future fires, reduce invasive species, and provide jobs and revenue to help build a strong rural economy.

The biomass facility will provide a marketable end-use for biomass removed from within the county, lessen Tuolumne County's reliance on imported energy, reducing greenhouse gases, and producing jobs in the region.

The Community Resilience Center (CRC) will provide social resilience to Tuolumne and surrounding counties. Tuolumne County is a regional leader in responding to disaster, with the region's only food bank and major evacuation center. Therefore, during emergencies in neighboring counties, they often turn to Tuolumne County for support. The proposed resilience centers will be located in a community selected with input from the communities in the County.

The Rim Fire destroyed permanent public infrastructure, including the ingress egress road systems, as well as erosion and landslides that undermine the integrity of the system and wear and tear from ongoing fire recovery efforts have caused additional damage. The Rim Fire destroyed rangelands, fencing, and water troughs that had been in use by cattle ranchers under long-term agreements with the USFS and now prevents grazing in the forest.

The damage from the Rim Fire has long-lasting effects well beyond the forests. Local communities, which are closely linked to the health of forests through timber, wood products, the recreation industry and tourism, continue to suffer from the business losses and closures caused by the fire, the direct public health impacts, and depressed property values. Damage to downstream water storage and supply, as well as the long-term implications for carbon storage, all have global effects.

From a regional perspective, the Target Area has experienced regular wildfire events, as shown in the Tuolumne Burn History Map. The 1987 Complex Fire burned 157,000 acres in Tuolumne County, much of which burned again in the Rim Fire. Natural regeneration of trees following wildfires that burn as hot as the Complex and Rim fires is often insufficient, resulting in conversion from forest to grass and shrub lands, which are more susceptible to high severity fires and store substantially less carbon than healthy forests. Overall Progress Narrative:

The two final Longterm Committments were met. The County of Tuolumne adopted their General Plan on January 2, 2019. The General Plan included the County Water Management Plan.

For the FWHP pillar: the USFS has entered into approximately eight million (\$8,000,000) dollars of contracted work. Of this contracted amount, it is anticipated that approximately four million dollars (\$4,000,000) in forest work will be completed in this calendar year.

For the CRC pillar: the County completed phase one of the CRC feasibility analysis. This included completion of NEPA/CEQA reviews, final schematic drawings and cost estimates for the CRCs. Final public meetings were held to solicit input on the CRC concepts and provide updates on service providers who will be using the CRC. County prepared CRC feasibility proposal for HCD review and approval prior to moving onto phase two implementation. For the BUF pillar: Beck Group completed the BUF feasibility studies. The studies documented that development of one or more biomass facilities in the county was financially feasibible and that there was sufficent biomass feedstock in the area to support existing biomass facilities and new biomass businesses too. SNC and HCD have engaged with Rural California Housing Corporation (RCAC) to become a subgrantee and administer the BUF project implementation activities. RCAC, HCD and SNC have develop a scope of work for implementation of a BUF economic development funding activity and are moving forward with a formal NDR agreement to secure RCAC economic development administration services.

Activity Progress Narrative:

County completed two budget amendments for consultant contracts under the CRC planning and feasibility study. The additional funding paid for final schematic plans with cost estimate. The additional funding was also used to complete the environmental reviews on both projects. Sufficient feasibility analysis has been done with the consultant work for the county to hold final public meetings on the CRC. Two public meetings were held in March in the communities where the CRCs are to be located. HCD staff supported county staff at these public meetings in discussion about the CRC design and feasibility as well as next steps in the approval and implementation process. HCD staff took the opportunity of the public meetings to also visit the proposed CRC sites and discuss design criteria with county staff.

County is having feasibility study funds requests processed now that NCR Agreement milestone compliance issues have been resolved with HCD.

The county began procurement of consultant services for geo-technical services, which are needed as part of the CRC feasibility study. It is anticipated that the geo-technical contact will be executed in May and work will be completed in June.

The county began drafting up a final CRC proposal for review by HCD and Core Team, based on the final feasibility reports. The proposal will recommend the development of two proposals. It is anticipated that HCD and the Core Team will review and make a final decision on feasibility of one or two CRC facilities in the next quarter.

Noxious Weed Abatement Activity: USFS has bid out weed spraying work in the area where a controlled burn was



conducted in fall of 2018. The burn treated 1,100 plus acres of deer habitat and annual weed spraying is needed to ensure native plants establish dominance. USFS began force account weed spraying in sensitive areas where contracted spraying was not advisable.

Rangeland Project 1 & 2 Activity: No activity took place on Rangeland Two. The Rangeland One project activity for fence rebuilding that did not have a completed bid process last fall was released in March with bids to be received and awarded in May of 2019. USFS and SNC are working on a NDR Agreement for California Conservation Corps (CCC) to ensure their work crews will be able to complete one fence project in 2019. The fence project has been agreed upon and timing and logistics for the work crews have been finalized. HCD will ensure that a NDR agreement is in place with CCC to allow them to start work in 2019.

Biomass Removal and Fuel Reduction Activity: USFS released bids and awarded approximately eight million dollars in funding contracts for this activity. Of that eight million dollars, approximately four million dollars will be expended this calendar year.

Reforestation Activity: USFS bit out the site preparation contracting for this activity. All site preparation work will be completed in this calendar year. Tree planting will begin in spring of 2020.

Fuel Break Activity: USFS is finalizing a combined Widen and Good Neighbor agreement to allow for USFS contractors and crews to work on state and federal lands. HCD executed a contract with HELIX Environmental Consulting for completing fuel break environmental reviews. HELIX has completed a work plan for the NEPA/CEQA environmental review process. The Fuel Break NEPA/CEQA will be done in 2019. Fuel break improvements can begin in spring 2020.

Matching funds: Biomass removal is requiring the USFS to pay for necessary improvements to facilitate the activity. As such, USFS is paying for road improvements and hazard tree removal activities that are necessary for providing access to areas where biomass removal and fuel reduction activities are taking place. Beck Group also conducted the third and final public meeting in front of the Tuolumne County Board of Supervisors on February 12, 2019. At that public meeting Beck Group and SNC presented the results of the two studies and took public comments from local citizens and Board members. Local residents and stakeholders expressed support for the study and the analysis. Both the Board and local citizens encouraged HCD to pursue providing NDR funding of BUF project implementation. Beck finalized the study documents and were paid their final reimbursements

Tuolumne County is currently in the process of updating its General Plan. The Draft Environmental Impact Report (EIR) was available for review on the County's website during a public comment period that ran from 12/7/15 through 2/5/16, with 2 public meetings 1/21/16.

The General Plan update includes the following:

- -Economic Development: commitment to align County resources with agencies providing job training and business development for the Central Sierra Nevada region
- -Natural Resource: support biomass energy facilities, manage invasive plants and vegetation removal for fuel reduction, and balance conservation with fire hazard reduction
- -Water Resource: align goals with climate adaptation strategies at the state level, support water harvesting and storage, develop policies and programs to adapt to extreme climate effects such as drought and flooding

The County Planning Director retired during the process, creating a delay in completion. A Request For Proposal (RFP) for General Plan Services will be released late summer 2017. It is estimated that it will take 6-8 months to complete revisions to the County's General Plan and have the Plan revisions adopted.
