

All awards are finalized.

#### 2021 CDBG NOFA

- ▶ 64- applications submitted and reviewed for threshold
  - ❖ DQ letters will be EMAILED out by Monday of next week.
  - ❖ Final scoring of applications will be completed once the threshold appeal period has ended. That has been extended from 5 to 10 days from date of notification. 2021 NOFA amendment #2 will address that, should be posted soon.

## **New Financial Report Coversheet**

### **Question:**

Do you need to use the new financial form for 2018 grants?

#### **Answer:**

Currently it is not mandatory, however it will be mandatory following the 2022 NOFA. If you have any questions, issues, or feedback, please contact your Grant Administrator so that we can take it into consideration as the form is currently being piloted for CDBG-CV grantees.



#### 2021 NOFA Threshold Issues

#### **Question:**

Can you give feedback on what kind of issues people had on threshold for 2021?

#### **Answer:**

Threshold items we saw the most were not using the correct resolution, not putting attest language in the resolution, not doing a correct debarment check, not uploading the single audit, uploading audits with findings yet stating there were no findings, not completing the budget in eCivis, not defining matrix codes correctly, state objectives were not being met, and uploading documents that were not relevant.



#### **2022 NOFA Submittal Dates**

## **Question:**

Do you have an application submittal date set yet?

#### **Answer:**

The dates are not finalized yet but we are projecting opening up applications by March 1 and deadlines of May 2 for Community Development and June 1 for Economic Development.



#### **Point of Contact**

#### **Question:**

It would be very helpful if HCD sent management memos, reporting forms, etc. to the staff contact, not the authorized signature person. For example the county executive is not the person that needs the new reporting forms - staff does.

#### **Answer:**

Thank you for the feedback. If the person listed in eCivis is not the preferred point of contact, please reach out to your Grant Administrator or HCD Representative with the correct contact information so that our information on file can be updated.



## **Advance Payments for Business Loans**

#### **Question:**

Is there no way to use a lump sum drawdown for an enterprise fund or micro program?

#### **Answer:**

That is part of what we are exploring. Our apologies for the length of time it is taking to finalize whether or not advances can be made for CDBG-CV grantees. However, the prohibition is statutory. We are looking at options internally and have elevated this to a high priority for the CDBG-CV team.



## Social and Racial Equity Training

### **Question:**

Are there any plans for a training on addressing social and racial equity expectations? Section 5 on CV 2 & 3 had several questions related to this topic.

#### **Answer:**

Yes, we have not set a date for this training yet, but there will be training on this topic. There will be training in January or February and ongoing in the year to come.
