

2022 NOFA + Application Instructions

Question:

Thank you for verifying that the 2022 NOFA will include ED OTCs. When will HCD develop the ED OTC application steps and the process that will be used to evaluate the application? Will a timeline for when HCD will have clear ED OTC application steps and the process for approval be developed? This would be greatly appreciated as ED OTC's are significantly different from General OTCs due to CDBG underwriting requirements and more in-depth analysis of the project's ability to create/retain jobs

Answer:

Yes, we are in the process of developing the 2022 application based on the 2022 NOFA. The application will be rolled out in January 2022 and the timeline will be available then. We are currently requesting feedback from applicants and grantees to develop a second document that will serve as a step-by-step instruction manual to use when completing the EDC applications and all other applications. CV Funds for Rental Assistance Next Year

Question:

Has there been any discussions between CDBG Dept and ERAP folks for those counties that have used/allocated all their ERAP program funds thus there may be a need now for CDBG subsistence payments to capture the "gap"? Will we be able to get to use the CV funds for rental assistance again before some of these contracts expire next year?

Answer:

We understand the need for direction on this and the community need. For now, we recommend contemplating using any new CDBG for legal services to assist households facing eviction or in dispute with their landlords. We will have further direction on whether we will be able to allow rental assistance in the coming weeks.



Disposal of Surplus Land

Question:

Does HCD have any draft resolution/noticing templates for the disposal of Surplus Land?

Answer:

HCD does not have this currently. Please check with the legal department at your unit of local government. If you have more specific details you want to discuss, a meeting can be set up through your Grant Administrator for specific guidance.



Federal Provisions Used in Contracts

Question:

Per Ch 5 Procurement:

"All contracts executed for performance of CDBG related activities must include a full and complete description of the federal and state requirements for contract compliance. The following documents must be physically attached to each contract as applicable Professional Service Contracts must include all required Federal Contract Provision as outlined in the Grantee's Standard Agreement. "

The Federal Provisions in the Standard Agreement which is assumed to be Exhibit D have a number of regulations that would not apply to a contractor and many contractors are hesitant to execute a contract in which there are provisions that do not pertain to their scope of work. Example below for context only.

Will there be guidance on what federal provisions should be in contracts?

Answer:

Certainly, there will be specific requirements and provisions based on the specific roles and type of agreement that is being executed, as well as the specific project. Contractual agreements between the state and the contractor or the grantee and the contractor will include all provisions. If the language is changed or adjusted from what is provided, the risk to parties included in the agreement will increase, therefore it would be prudent for the grantee to include a standing boiler plate that calls out the "applicability" of each provision/requirement. Instead of removing language, adding in the "if applicable" language will protect all parties involved in the contract.



Survey Submission

Question:

Are you still accepting the surveys that were sent out last week?

Answer:

There are actually two surveys sent out recently. One regarding satisfaction with the 2021 NOFA and application, and one regarding technical assistance and training needed for CDBG-CV. Both are still being accepted.

If you are having issues completing the survey, please contact your CDBG rep or grant administrator as it is important to gather this information to ensure that we are doing our best to serve grantees.



Program Guidelines

Question:

We are currently managing a CV Business Assistance programs and the problem we are facing is that most applications are not demonstrating a loss of revenue. Is job creation/retention enough to suffice the program guidelines?

Answer:

This type of matter is something that you would need to work with your GA on for specificity purposes. You will most likely be able to utilize the COVID nexus, but the particular contextual information that is needed to confirm is something that your GA can work with you on identifying.



SAM.gov Registration

Question:

Any update on SAM.gov registration being required for every business that is assisted with Micro ED funds?

Answer:

It is a requirement for all businesses to register at SAM.gov and receive a DUNs number in order to be eligible to receive assistance. A DUNs number is needed as part of the debarment check, so this must be completed before an award can be given to a business. If you have a need for technical assistance to understand the process, please reach out to your CDBG Rep or your Grant Administrator. In order to retain eligibility, this also must be updated annually.

All contractors must also register on SAM.gov and update annually.



Sub-Recipient Trainings

Question:

 Thank you for offering a sub-recipient training in December. Is this a training we should recommend to our sub-recipient organizations?

Answer:

 Depends on the training; we will follow-up on which trainings should be shared with your sub-recipient organizations.



Public Services and Pl

Question:

Our county has conducted a community assessment in an effort to understand needs of low-income households; certain public services were identified as a need. The County has PI that they would like to expend but understands that public services are not being approved under PI applications. There is an identified need, funds are available; however, the service is not eligible for the target population. When does HCD expect public services projects to open so that we are able to spend our PI down?

Answer:

This is determined by federal regulations. These regulations have put a cap on the percentage of what the state can use for public services. If we allow PI only applications for public services, that will count towards the percentage and would likely end up exceeding our federally regulated cap. There will be a public services set-aside in the 2022 NOFA and we recommend applying for those funds.
