## Veterans Housing & Homelessness Prevention (VHHP) Program 2017 Round 3 Awards Summary

Based on current project awards, the VHHP Program estimates that 44% of housing units expected is reserved for veteran households, while VHHP funds account for 15% of total development cost for a 200% return on investment.

### CALIFORNIA VETERANS HOUSING NEED

The majority of veteran households are considered economically burdened (spends more than 30% of income on housing related costs) or severely burdened (spends more than 50% of income on housing related costs), according to the National Low-Income Housing Coalition using 2015 Public Use Microdata Sample (PUMS) data. Note: AMI = Area Median Income
