Assignor further understands that the Director is authorized to reduce the sum of said cash deposit to the extent of all claims owing the Department of Housing and Community Development arising from any loss or damage on account of any defect in or undisclosed claim upon the right, title and interest of the Assignor or other person in and to the above-described unit, and reasonable attorney fees and administrative costs incurred in processing claims against such cash deposit; that the reduction of such deposit by any amount is grounds for automatic cancellation of the Certificate of Title, under the provisions of Section 18122 of the California Health and Safety Code, until such time as the cash deposit is restored to its original amount.
