Encampment Information

1. Briefly describe the characteristics of the people residing within the prioritized encampment site. The description must include demographics and may include household compositions, disabilities, and projected service and housing needs. (1500 character limit)

The City of Salinas Outreach and Response Team (SORT) engages with unsheltered individuals within the City boundaries, including the prioritized encampment site at Carr Lake. SORT's most assessment of the site indicates there are about 70 tents and structures with 80 people residing in the area. Data on the residents and their needs comes from a recent SORT assessment and HMIS UDEs from the City's current

ERF-1 project which serves a similar population. Carr Lake residents are estimated to be about 60% men. Ages range from 25-45. Virtually 90% are Hispanic/Latino and primarily Spanish speakers. An estimated 75% are undocumented and in need of immigration and criminal defense support with the remaining 25% having work visas or residency papers. Just over 30% of the residents have substance use disorders and 25% are in need of mental health services. 50% have medical insurance that would allow them to access health and behavioral health services. Most residents have income from field work, recycling bottles and under the table jobs. Many are struggling with securing housing due to being undocumented and having very low incomes. Many have reported to SORT that they have suffered some sort of trauma, including gang threats and altercations. Services needs identified by the residents include mental health, substance use treatment, criminal and immigration services, employment/income, food, interim and permanent housing.

2. Briefly describe physical characteristics of the prioritized encampment site in which the people you are proposing to serve are residing. The description must include the specific location, physical size of the area, the types of structures people are residing in at the site, whether vehicles are present, and any other relevant or notable physical characteristics of the site. The Carr Lake encampment is on two parcels of land totaling about 26.55 acres located along Gabilan Creek, which runs through the northeastern quadrant of the city. Nearby structures include a large County Public Works yard, the City-funded regional SHARE Center navigation shelter, and a large residential apartment complex. The site is relatively undeveloped and part of a larger nature focused park. It has only natural light. Some portions of the site are wooded with trees and shrubs while others are very open, consisting of dirt or grassy areas. A bike path and community trail both lead to and pass by the encampment site. The path leads towards the Natividad Hospital and a shopping center to the north and into residential homes of the Acosta Plaza neighborhood in the south. Encampment residents have set up tents and built hand-made wood and mud structures to live in. There are also 3 to 4 occupied vehicles at the site.

3. Why is this particular encampment site being prioritized? (1000 character limit)

This encampment is prioritized for two reasons. First, encampment residents are highly vulnerable due to existing physical and mental health issues, lack of citizenship, and a lingering presence of gangs and crime. They are also vulnerable to hazardous pesticides from nearby agricultural fields and runoff flowing from Gabilan Creek which also poses the risk of flooding during heavy rain. These individuals will be much healthier and safer if sheltered or housed and connected services. A second priority concern are impacts on community health and safety. The continued presence of the Carr Lake encampment creates significant impacts to the larger community. Debris and refuse runoff originating from encampment flows to a marine sanctuary, creating public health risks and environmental concerns to communities downstream. Community members do not feel safe using this public area and facilities nearby, particularly given the presence of gang members in and near the encampment.

Proposal's Outcomes

- 5. What are the outcomes this proposal seeks to accomplish by the grant close (6/30/2026)? If funded, what are the primary activities you are planning to implement to achieve the proposal's outcomes? (1000 character limit)
- 1. Outcome: 95% will engage with outreach. Activity: Trauma-informed outreach services provided by SORT, VHA, Interim Inc.

- 2. Outcome: 85% will enter interim housing. Activity: Interim housing project through leasing of motel providing case management and housing navigation services; leverage placements in other IH programs.
- 3. Outcome: 70% will secure permanent housing. Activity: placement in new, awarded Project Homekey, Project and Market based housing and RRH incentives.
- 4. Outcome: 40% will receive flexible rapid rehousing and problem-solving funds.
- 5. Outcome: 75% will access immigration services. Activity: Catholic Charities immigration and post-conviction relief services.
- 6. Outcome: 25% will maintain or increase income. Activity: service connections through SORT.
- 7. Outcome: 25% will access mental health services. Activity: Interim Inc. outreach, programs, and service connections.

6. How will the applicant measure progress towards the proposal's outcomes? (1000 character limit)

All participants in this ERF-2R project will be entered into HMIS. All project partners will be trained on service tracking, referrals and identified outcomes. All will have HMIS access to upload personal records and enter HUD required UDEs. SORT and partners will use HMIS as the primary method for tracking services provided, referrals to project partners and shelter, and housing outcomes. The City will regularly generate and use a 'client served' report with services transaction outcomes to report to CAL-ICH quarterly. This system was developed through collaboration with the Coalition of Homeless Services Providers (CHSP), the CoC and HMIS lead agency for our county, during ERF-1. CHSP is a collaborative partner in this proposal and will be responsible for HMIS system set-up for all project partners as well as the provision of HMIS and CE training. CHSP will track the results of housing referrals through its administration of the regional CES.

7. Are there any local ordinances, resources, or other factors that may hinder achieving the proposal's outcomes? If so, how will the applicant navigate these challenges? (1000 character limit)

There are no local ordinances, resources, or other factors that will hinder the achievement of the outcomes in this proposal. The City acknowledges a primary challenge of securing housing placements for the encampment residents, given the high cost of rents (recently reported as the 4th highest in the U.S.) and the need to resolve significant barriers including legal immigration and citizenship pathways. Homelessness and access to affordable housing have been identified by the Salinas City Council as top priorities. With this in mind, the City has and continues to pursue all available avenues and resources to resolve the presence of homelessness in its community and is committed to pursuing emerging opportunities and prioritized leveraging of available resources to the fullest extent possible.

Part 3: IMPLEMENTATION

Core Service Delivery and Housing Strategies

9. Describe the proposed outreach and engagement strategy, case management, and / or service coordination for people while they are continuing to reside within the encampment site. Quantify units of service to be delivered including the ratio of staff to people served, frequency of engagement, and length of service periods. (2000 character limit)

The project's engagement strategy will include continued deployment of SORT-led outreach inclusive of specialized partner staff to engage and assess Carr Lake encampment resident. Engagement will be trauma-informed and housing-first oriented and inclusive of case management and transportation services. Having already engaged with many of the Carr Lake residents, SORT is poised to make appropriate, efficient linkages to other project partners for specialized services. SORT will be on-site at the encampment a minimum of 5 times per week for 2-3 hour periods providing services at a ratio of 1 staff person per 25 residents, including the leveraged SORT staff. The City will include three specialized outreach partners. Interim Inc. will provide mobile biopsychosocial assessments to encampment residents and connections to the mental health system with a ratio of 1 staff per 20 residents. Valley Health Associates (VHA) will provide substance abuse navigation services to encampment residents with a ratio of 1 Peer Specialist per 25 clients. In acknowledgement of lessons learned from the City's adjacent ERF 1 project site, this application proposes an expansion of immigration and citizenship services/supports to allow for the extensive legal case management necessary to successfully address and resolve legal barriers to lawful status. This strategy includes a dedicated Immigration and Criminal Post-conviction Attorney and full-time Immigration Case Manager who are expected to serve 75% of encampment residents. Upon launch of the project, SORT will increase its engagement with residents in preparation of a focused move from the site to either interim or permanent housing. SORT's staff will also expand and develop by adding a new Housing Navigation Program (HNP) (see question 11). The HNP will coordinate closely with the outreach team to identify those who are making significant strides to a pathway to housing. It is projected that this will last for 12 to-24 months.

10. Describe the role of Coordinated Entry in the context of this proposal and how Coordinated Entry policies or processes will support and / or hinder the implementation of this proposal. (1000 character limit)

HSP is the regional CoC lead agency and oversees both HMIS and Coordinated Entry. CHSP is a project partner and will monitor and lead the completion of standardized CES assessments to ensure appropriate permanent housing referrals and will use CE and HMIS to assist in tracking housing outcomes. While CE is an important local resource, there are significant limitations as the list of people waiting for a housing match is long resuliting in only those with the highest prioritization score receiving a referral and limitations imposed by federally funded programs. As a regional tool, CE is a challenge in attempting to match Salinas residents to preferred Salinas housing. In response, the City of Salinas has collaborated with CHSP to screen-in referrals from its Emergency Motel Program to its Homekey Projects. Given the encampment's demographics, it is anticipated that a relative low number of Carr Lake residents will secure a housing solution through CES.

11. Please describe the interim shelter and permanent housing opportunities proposed to support this proposal and provide evidence of the applicant's demonstrated ability and commitment to deliver permanent housing for people residing in the prioritized encampment. (2000 character limit)

A primary goal of this project is to secure interim and/or permanent housing for Carr Lake encampment residents. In doing so, the City is plans to leverage funding to lease a 42-unit motel, security and operating staff to provide interim housing, with 30 units set aside for residents of the encampment. Over the course of the 24-month engagement period, we project that up to 45 individuals can be housed at this low barrier, non-congregate, City-staffed site. ERF-2R funds will support the continued operations and staffing of interim housing with 1 Site Coordinator, 1.5 Housing Navigators, and 2 Case Managers dedicated to

providing ongoing emergency shelter and housing stabilization and navigation support. 24/7 security services are also supported. Based on experience gained during the COVID 19 pandemic, the City is well-experienced in funding and managing this type of project and anticipate that many Carr Lake residents will accept placement at this program. SORT will facilitate placement in other existing housing programs for those who choose not to move to the motel including the SHARE Center, Chinatown Navigation Center, Dorothy's Place, and the Casa de Noche Buena. Permanent housing pathways will be created through several strategies including an expansion of the SORT to add a new Street Based Housing Navigation Program (HNP). The HNP will provide intensive housing support to encampment residents, including conducting initial assessments and housing search, supporting applicants throughout the housing application process including landlord engagement, and housing retention services. The HNP team will have access to a pool of flexible rapid rehousing and problem-solving funds through the ERF grant to assist participants in securing housing through CE. Some encampment residents will be referred to one of three new Project Homekey sites that will become operational within the first 12 months of the grant period.

12. Describe how this proposal is tailored to meet the needs and preferences of people residing within the prioritized encampment. (1500 character limit)

The City of Salinas is committed to ensuring that all services to be provided through this project will be trauma-informed, voluntary, low-barrier and culturally responsive. SORT has interviewed residents living in Carr Lake to identify the specialized needs and partners embedded in this application. Participants will be offered choices in terms of the types of services, shelter and housing available and their self-determination will be respected. Outreach, services, and shelter to be offered through this grant all integrate data-informed; evidence-based interventions such as motivational interviewing. SORT is highly skilled in engagement and meeting people where they are. They offer resources to meet immediate needs (e.g., food, equipment, clothing, IDs, transportation), build trust and develop rapport to engage residents to do an assessment and help them access shelter and housing as well as other services such as healthcare, mental health, substance use services, etc.

13. Describe how this proposal considers and plans for the dynamic nature of encampments including potential inflow of people into the geographically served areas. (1000 character limit) In consideration of threats and living conditions, current encampment residents are a fairly stable group that has been there for a sustained period of time. The City recognizes the migratory nature of encampments as a result of various health and safety initiatives and implications of inclement weather. Many of the Carr Lake residents are former occupants of an adjacent encampment recently cleared due to environmental issues mandated State-level compliance. A primary focus of ERF services and housing is to work with current residents and support their access to interim/permanent housing and vital supports. If additional individuals come to the site, ERF funds will serve a maximum of 90 participants. Numbers in excess of this, will be engaged and managed by SORT to identify and provide alternative options, resources, and solutions.

14. Describe how this proposal will support individuals with continued access to and / or the storage of their personal property. (1000 character limit)

SORT will assist encampment residents in assessing their belongings and identifying appropriate storage options for those entering interim housing at the IH motel program, most will be allowed to bring reasonable belongings into their units and the facility's onsite storage facilities. The City's Chinatown Navigation Center does not offer storage but provides City-funded, accessible off-site secure storage. ERF funds are requested in the budget to augment the City's current storage unit offerings for up to 6 months for encampment residents who have no other storage options. Funds will be available for up to 10 individuals.

15. Describe how this proposal will support individuals with service animals and/or pets. (1000 character limit)

The city is committed to ensuring that encampment residents are not separated from their pets and the vital consistent comfort and support they bring. The interim housing motel program allows residents to have pets in their units (up to 2 pets is the current City policy) and provide a designated outdoor pet area. The Chinatown Navigation Center and Share Center also allow pets and have kennels available for this purpose. SORT provides pet food, dog beds and other supplies for unsheltered individuals during the outreach process. They also assist the unhoused residents with connection to a community volunteer who will foster the animals should they decide to go into an emergency shelter or treatment program that does not allow pets. The SORT team also connects residents to the SNIP program that will provide free Rabies shots, DHHP shots for \$10, Microchipping for \$15, and access to spay/neuter services.

The budget for this proposal was thoughtfully developed by the City in collaboration with our provider partners and draws upon our shared experience with our current in-progress ERF-1 project. Requested funds will provide not only intensive outreach, engagement, and service coordination, but will also help support the expansion of low barrier, non-congregate interim housing in the City of Salinas, and the introduction of an innovative street-based housing navigation program. In addition to ending homelessness for a very high vulnerability group of individuals at Carr Lake, this grant is considered to be a targeted investment in the City's homeless service infrastructure that will continue to help meet the needs of unsheltered individuals in Salinas beyond the term of the grant. As with its other grants and programs, the City of Salinas is dedicated to leading by example and readily shares its models and resources with other communities and jurisdictions.

Key Entities and Staff

responsibilities for this proposal. Finally, if these entities have managed a complex homelessness project or grant, describe how those experiences informed this proposal. (1500 character limit) The Implementing Unit for the proposed project will be the City of Salinas Housing & Community Development (HCD). HCD will be responsible for administering the ERF funds, contracting with partners, monitoring, data collection and reporting. Within HCD, the City's SORT Team will assume primary responsibility for programmatic implementation, including service coordination for encampment residents. SORT will coordinate regular meetings of the collaborative partners, conduct regular case conferencing meetings for clients, and participate in the City's monthly internal homeless coordination meetings and various CoC CES and HMIS meetings. The City of Salinas has extensive experience managing complex projects serving people experiencing homelessness. The city was one of the recipients of initial ERF Round 1 funding to resolve a nearby adjacent encampment area along Natividad Creek. Implementation of this project is already underway and many encampment residents have already secured interim or permanent housing. The City administers a significant amount of local, state and federal entitlement and grant funding including CDBG, PLHA, CESH, ARPA, and General Funds and serves as the Administrative Entity for CoC ESG funding for Monterey County. Including Homekey and Roomkey funds, in recent past years the City has administered over \$50 million annually to fund Street Outreach, Emergency shelter, Rapid Rehousing, and Permanent Supportive Housing.

The following project participants will hold collective responsibility for service provision and outcomes in collaboration with the City of Salinas.

Catholic Charities will provide immigration services for program participants and will leverage services to

connect participants to benefit programs (CalFresh, MediCal). Catholic Charities has extensive experience working with unhoused individuals and is a partner in the City's ERF-1 project.

Interim Inc. will provide mobile mental health services (outreach), initial clinical assessments, and firm linkages to available County mental health services to encampment residents. Founded in 1975, Interim also serves as the lead mental health provider of the County's McHOME program providing support services, permanent supportive housing and treatment for adults with mental illness.

Valley Health Associates will provide a mobile outreach worker to engage clients regarding substance use and will navigate participants to supportive substance abuse treatment and services. VHA is a licensed substance abuse treatment providers offering a range of services including Medication Assisted Treatment (MAT) in Monterey County.

The Coalition of Homeless Services Providers (CHSP) is the lead agency for the CoC and operates CE and HMIS.

Several interim housing providers will offer beds in their programs to encampment residents, including the Chinatown Navigation Center, SHARE Center and Dorothy's Place.

22. Describe specific examples of how Local Jurisdiction(s) and the CoC have collaborated on the design and implementation of this proposal. (1000 character limit)

The City of Salinas has a long-standing commitment to and high level of involvement in the Monterey and San Benito County Continuum of Care (CoC) and serves as its AE for HCD CoC ESG funds. Our Mayor sits on the CoC Leadership Council and staff participate actively in homelessness response system planning (i.e. the recently completed Five-Year Strategic Plan). For this ERF proposal, the City and CoC teams held several planning discussions to identify the prioritized encampment and develop and design the proposed program. This work built upon the successful ERF-1 grant developed by the City in collaboration with the CoC. The CoC is one of the collaborative partners in this proposal and will provide both HMIS and CE system support as well as assisting with coordination of the services to be delivered by partners. Once the project is launched, CoC staff will assist subrecipients in HMIS and train them to do the service transactions needed for ERF tracking and reporting.

23. Identify any entities that have a right to and/or control of the property upon which the encampment site resides and discuss whether each of these entities committed allowing the implementation of this proposal. If they have not committed, please explain how you have or plan to engage with this entity to implement your proposal. (1000 character limit)

The Carr Lake encampment is located on City-owned property and is a part of the Natividad Creek Park. The City is fully committed to the ERF project proposed in this application and looks forward to returning the encampment site to its original, nature-focused public use. In addition to the activities described in this proposal, the City of Salinas is prepared to assume full responsibility for cleaning and restoration of the site once all the current residents have moved to interim or permanent housing.

Centering People

24. How were persons with lived experience meaningfully incorporated into the planning and proposed implementation of this proposal? Please identify whether any perspectives were incorporated from persons that are currently unsheltered and / or formerly or currently residing within the prioritized encampment. (1000 character limit)

The City of Salinas strongly values the input of people with lived experience in all its work to address homelessness. This commitment includes hiring people with lived experience. The City's SORT team includes Peer Leaders who are people who have formerly experienced homelessness. These team

members have been instrumental in helping SORT establish relationships with Carr Lake encampment residents. Over the past several months, SORT outreach workers have engaged/interviewed residents about their service needs and interest in moving to interim or permanent housing. This proposal reflects what the encampment residents shared, in that it focuses on offering low-barrier interim housing with pathways to permanent housing and addresses other key barriers the residents identified including the need for help with immigration status, health and mental health services, substance use services, and income.

25. Briefly describe how the proposal exemplifies Housing First approaches as defined in Welfare and Institutions Code section 8255. (1000 character limit)

The proposed services and interventions will follow the CoC CA-506's written standards regarding Housing First, including the requirement that programs accept individuals regardless of sobriety, substance use, financial status, rental history, criminal convictions unrelated to tenancy, completion of treatment, participation in services, or behaviors that indicate a lack of "housing readiness." Outreach, interim housing, and other services provided through this grant will be held accountable for housing outcomes as their primary goal. Providers will be expected to develop housing and service plans that are client-driven, voluntary, and not a precondition of housing placement. Case managers, service coordinators, and related staff must be trained in and actively employ evidence-based practices for client engagement, including, but not limited to, motivational interviewing, trauma-informed care, de-escalation, harm reduction, and client-centered counseling.

26. Briefly describe how this proposal will center an individual's choice and provide trauma informed services and supports. (1000 character limit)

The project will provide trauma-informed and culturally appropriate engagement by SORT and partners using a model that emphasizes meeting people where they are and offering immediate and practical support as a way of building trust before suggesting participants consider more intensive services, shelter or housing. SORT includes two Peer Leaders with lived experience who will support engagement at the Carr Lake encampment through the proposed program. Through the success of the City's ERF-1 grant, these Peer Leaders were originally recruited from encampments in Salinas and are now employed as part-time City employees. Peer Leaders are trained in leadership skills and support outreach efforts to connect unhoused residents with services. All proposed partners are well versed in providing trauma informed services and fully understand the full range of service and housing options to be offered to encampment residents.

27. Describe how this proposal will operationalize harm reduction and provide services that improve a person's health, dignity, and safety while they continue to reside within the prioritized encampment site. (1000 character limit)

Harm reduction is a primary focus of this project and the SORT Team and provider partners all operate using a harm reduction orientation and are trained in this approach. No one will be denied services, shelter or housing due to lack of sobriety. VHA is the primary community SUD provider and will help navigate interested residents to a range of different treatment options based on their needs and choices. This may include MAT and other treatment options that are not abstinence-based. Each program component will be performed while protecting the health, wellness, and dignity of the encampment residents. This means prioritizing the needs and safe movement of encampment residents over any rush to empty the site; providing immediate healthcare and basic needs provisions to residents during outreach; prioritizing client choice in shelter and housing options; and providing multiple housing options to ensure options for clients are available.

28. For encamped locations that are objectively dangerous, describe how the proposal will seek to prevent harm for people experiencing unsheltered homelessness in these locations. (1000 character limit)

Dangers currently present at the site include gang activity (residents feel threatened and do not report crimes); unhealthy conditions (lack of utilities and clean water); reoccurring instances of accumulated

debris and accompanying sanitation concerns; and risk of flooding during heavy rain. During the January 2023 atmospheric river event, the City provided the encampment residents with tents and transportation to shelter. A primary strategy to prevent harm is to help residents identify interim and/or permanent housing that meets their needs so they can move from the encampment. Reducing danger will depend on helping them transition to safer places.

29. Identify what controls are or will be in place to ensure that all ERF-2-R funded parties will not penalize homelessness. The term "penalize homelessness" means to impose, by a governmental unit, criminal or civil penalties on persons who are homeless in a manner that is related to those persons' engagement in necessary human activities, including sleeping, resting, and eating. (1000 character limit)

Local laws and ordinances that impact encampments include Chapters 14, 16, and 29 of the City of Salinas Municipal Code (prohibition on littering; health and sanitization; prohibition on camping; storm water management and discharge control) as well as the State Trash Amendments (prohibition on trash from entering waterways by 2030; prohibition on water quality impairments; prohibition on littering; prohibition on illegal dumps into bodies of water). The current Carr Lake encampment violates each of these laws and ordinances, but the City has intentionally avoided any issuance of citations, instead opting for a more compassionate approach through the lens of dignity safety, and wellness that is focused on strong outreach, service connections, and immediate shelter and housing options. No other grant partners would have the power to impose penalties.

30. Describe how this proposal considers sanitation services for people residing in the prioritized encampment. This may include but is not limited to non-intrusive, curb-side waste removal and access to clean and available bathrooms. (1000 character limit)

The City of Salinas currently provides portable restroom and handwashing stations at the Carr Lake encampment. The Department of Public Works and contracted Downtown Streets Team provides ongoing trash pick-up and large debris removal on a regular basis. Once the ERF project launches, the SORT team will work with residents for up to 24 months to facilitate their move to interim or permanent housing. Following an initial 12-month period focused on relocating all encampment residents to proposed housing options, the City will conduct a more extensive site clean-up to return the site to its original nature-focused, recreational use.

Accelerated Timeline

31. How is your community currently supporting and / or engaging with people residing within the prioritized encampment? (1000 character limit)

On the heels of its ERF1 award, the SORT has engaged residents at Carr Lake for over a year. These efforts have focused on establishing trustful, active relationships, providing assistance with basic needs, conducting preliminary health and safety assessments, and service coordination and linkages. The City's team includes two Peer Leaders with lived experience of homelessness. In preparation of this application, SORT sought input from residents in regard to service needs and immediate and interim housing interest and preferences. Additional supports have been limited by a lack of funding. In spite of this deficiency, the Downtown Streets Team provides regular sanitation support, Clinica de Salud mobile unit provides healthcare, and Access Support Network (HIV, HepC, needle exchange) while other proposed grant partners including Valley Health Associates (substance abuse services), and Interim, Inc. (mental health) seek to meet other basic needs at the encampment at the City's request.

32. If this proposal is selected, in advance of receiving funding, what steps will your community take to support the people living in the encampment and swift implementation of this proposal? (1000 character limit)

If the grant is awarded, the City will immediately move to expand its SORT team capacity and service model to include a Street-based Housing Navigation Program (HNP). The current intermittent services provided by Interim Inc. and Valley Health Associates will receive dedicated funding to provide fully-funded

mobile mental health and substance use outreach at the site. Together, these outreach teams will quickly move to begin connecting people to expanded grant-funded and leveraged services, including immediately available interim and permanent housing. Following an initial 12-month period of engagement and supportive movement of encampment residents to interim and permanent housing, the City will initiate a significant clean-up of the site to return it to its intended public, nature-focused use.

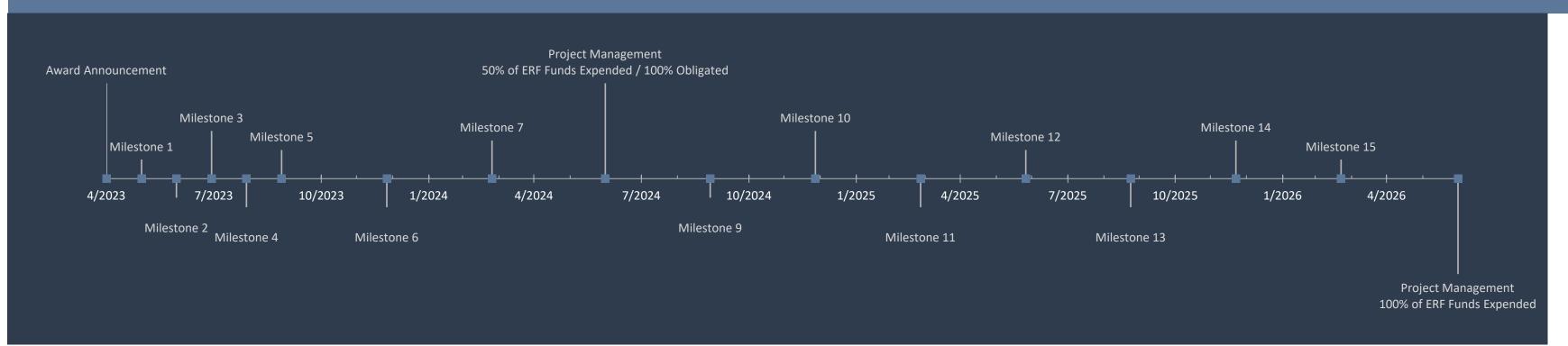

SORT Carr Lake Assessment



- It was calculated that the Carr Lake Encampment has 70 tents and structures located along the Carr Lake creek and surrounding pathways in proximity of the Lake.
- Households vary from 1-2 individual(s) in small tents/structures, to 3-4 individuals in larger sites per household. SORT estimates around 80 people reside in the encampment; in interviewing some residents, they perceive this calculation to be correct.

 - 62 individuals have been identified with by first name, at minimum

 - o Undocumented Residency: 38.7% (24/62) unknown 27.4% (17/62)

- o It is perceived by SORT that 10-15 individuals may need mental health services, however a majority are undocumented and are barred access to services
