### **Proposal Summary**

Summarize the proposed Encampment Resolution Fund (ERF) project, including an overview of all key components and/or phases of the project that will be funded in whole or in part with ERF-3-R resources. (1500-character limit)

The Encampment Resolution Fund (ERF) project proposed by the City of Oceanside, in collaboration with the City of Carlsbad, is a comprehensive initiative targeting homelessness around the SR 78 Caltrans Right of Way and Buena Vista Creek areas. The project uses low-barrier, person-centric methods that follow Housing First principles. Caltrans has previously supported Oceanside's Encampment Resolution, which aimed to improve infrastructure safety and well-being of unsheltered individuals.

Enhancing the project, the City and its partners will leverage and expand interim housing solutions, including the Oceanside Navigation Center, the Oceanside Bridge Housing program, the La Posada Shelter, and a scattered-site motel voucher program. A Safe Parking Program also offers a secure environment for people living in vehicles.

The project uses a multidisciplinary team approach to provide wrap-around services for intensive case management, peer support, street medicine, harm reduction, mental health support, and housing navigation, tailored to each individual's needs. The local HMIS will provide real-time data tracking with case conferencing centered around a By-Name List.

The project prioritizes permanent housing opportunities utilizing family reunification, landlord incentives, shared housing, prioritized and dedicated Housing Choice Vouchers, PSH developments, CES, and expanded RRH to help people exit homelessness to permanent housing destinations as quickly as possible.

### **Encampment Information**

1. Briefly describe the characteristics of the people residing within the prioritized encampment site, including demographics, household compositions, disabilities, and projected service and housing needs. Include how this information was gathered. (1500-character limit)

The people residing in the prioritized encampment site are both unsheltered and living in vehicles. The majority of the unsheltered have high service needs including physical and developmental disabilities, mental health issues, substance abuse disorders, and co-occurring conditions. Many also have chronic health conditions. The unsheltered are mostly single person households, and the majority are men. The people living in vehicles include a mix of single and multi-people households. They also have some of the same characteristics of the unsheltered households but tend to have less severe service needs. They are living in a variety of vehicles from small sedans to RVs. Based on data from the City of Carlsbad's By-Name List and the annual Point-In-Time Count, about 75% self-report characteristics meet the federal definition of being chronically homeless, but their status needs to be certified. A third report substance use, and 25% are justice-involved, either on parole or probation. The people residing in the area are disconnected from services with limited or no access to housing solutions, healthcare, transportation/mobility services and food resources because the majority of the encampment area is far from mainstream resources. The diversity of the demographics requires a variety of housing options and resources to meet the population's needs. The majority will need significant assistance to obtain housing and then consistent support to stabilize and maintain housing.

2. Briefly describe physical characteristics of the prioritized encampment site in which the people you are proposing to serve are residing. The description must include the specific location, physical size of the area, the types of structures people are residing in at the site, whether vehicles are present, and any other relevant or notable physical characteristics of the site. The priority encampment is located along the California State Route 78 corridor and Buena Vista Creek area between the border of the City of Oceanside and the City of Carlsbad. This area encompasses property along the border of both cities and several State rights-of-way maintained by Caltrans. The terrain here is diverse, including freeway embankments, sidewalks, parking lots, and dense trees and bushes with active water flow. The creek area is highly susceptible to flooding, fires, and contaminated water. This corridor has several encampment groupings, and people often move between locations along the corridor, including between more commercial and secluded areas. Both unsheltered individuals and people living in vehicles can be found here. The unsheltered encampment structures primarily consist of make-shift tents and tarps, with some people sleeping without cover using blankets or sleeping bags. The vehicles include small sedans, trucks, vans, and RVs.

# 3. Why is this encampment site being prioritized? Applicant should identify any distinguishing needs and/or vulnerabilities of the people living in this encampment and/or any health, safety, or other concerns that led the applicant to prioritize this site over other encampments. (1000-character limit)

The Priority encampment stretches following State Route 078 and ends at the cost of connecting with State Route 05. The area includes the Buena Vista Creek Ecological Reserve and Quarry Creek Preserve, which have several sensitive native species impacted by the encampment. It is a high-risk Floodway zone with several hazards that pose a significant risk to public health and safety. Drainage facilities, channels, and creeks are unsafe for habitation, primarily during flooding and fire events. The risks include drowning, exposure to viruses and bacteria from contaminated floodwaters, cold weather-related illnesses, high winds, burns, and structural damage from fires. Due to the high concentration of people living in the area, there have been ongoing complaints from the community, both in Oceanside and Carlsbad. The proposal can help encampment residents move to permanent housing, increase safety, and reduce community concerns.

ERF authorizing legislation requires funding be used for "prioritized" encampments. Applicants must, therefore, provide a justification for the prioritization of the encampment proposed to be served. ### **Proposal's Outcomes**

# 5. What outcomes does this proposal seek to accomplish by 6/30/2027? Outcomes should be specific, measurable, attainable, relevant, and time-bound (SMART). (1000-character limit)

The proposed Goal is to move 262 residents into interim housing and 196 into permanent homes by June 30, 2027. The Cities will establish Interim milestones to track progress using (HMIS) and By-Name-List to create monthly, quarterly, and annual reports. This report will track the progress of individuals served, sheltered, and permanently housed. The report will also display the number and types of contacts/touchpoints by our partnering service providers and improve services through data-driven decisions.

The proposal sets clear, measurable targets: ensuring permanent housing for most encampment residents, a key milestone in providing stable living conditions. For those with chronic health conditions, a significant goal is securing continuous medical care for at least 60%, thereby improving health outcomes and quality of life. Addressing substance abuse is also critical, and the plan aims for a 50% reduction in substance abuse issues among residents through harm reduction Programs.

# 6. What are the primary activities the applicant will implement to achieve each of the proposal's outcomes? (1000-character limit)

The proposal for the prioritized encampment area aims to address the diverse needs, challenges, and goals of the people residing there through various interventions. These interventions include expanding and improving emergency and interim housing, utilizing multidisciplinary teams for impactful outreach and case management, adopting a wrap-around model based on the By-Name-List, and using the dedicated homelessness Housing Choice Voucher Program. All interventions are personalized and centered around the individuals' needs and include trauma-informed outreach and engagement, transportation, health supports, access to public benefits, access to flex funding, bridge housing with case management, and permanent housing. The interventions will be delivered in a low-barrier, housing-first approach that includes housing stability supports, landlord engagement, deposit assistance, and rent subsidies. They will be provided where the residents of the encampment are, ensuring maximum impact.

## 7. How will the applicant measure progress towards the proposal's outcomes? (1000-character limit)

The project will use multi-disciplinary teams to engage, access benefits, reduce barriers, and ultimately support people in obtaining a permanent place to live. Progress will be tracked for each individual or household, monitoring engagement, benefits accessed, documentation procured, and housing obtained. The HMIS Annual Performance Report enables standardized progress measures. To ensure and measure progress, the cities will establish short (3 months), mid-term (9 months), and long-term (12, 24, 36 months) goals with deliverables and deadlines, and track progress on these deliverables and deadlines every month through the By-Name List. Feedback from individuals, service providers, and partners will be actively integrated into strategy refinement, ensuring alignment with person-centered and housing-first approaches.

# 8. Are there any local ordinances, resources, or other factors that may hinder achieving the proposal's outcomes? If so, how will the applicant navigate these challenges? (1000- character limit)

Several challenges may hinder the achievement of the proposal's outcomes. These challenges include limited housing options, high market prices, and community pressure for quick encampment removal. To overcome these challenges, the proposal will leverage and fund resources to increase interim shelter including motel vouchers, bridge housing, a new safe parking program, increased dedicated shelter beds, and reduced barriers to partnering shelters. To address high market prices, we will prioritize using affordable housing, HCVs, and shared housing when possible. The project aims to utilize resources funded by ERF to incentivize landlords and encourage them to accept participants with housing choice vouchers and rapid rehousing assistance at FMR. The project will use the Housing Navigation Program funding to cover lease-up expenses, including application fees, security deposits, utility deposit assistance/arrears, pet deposits, and other housing barriers.

# If it is part of a larger initiative, describe the role and significance of this project in achieving the objectives of the larger initiative. (1000-character limit)

The proposed project is aligned with the local CoC's Regional Community Action Plan aimed at preventing and ending homelessness in San Diego. It focuses on addressing critical system and resource gaps while promoting evidence-based approaches. This project significantly contributes to the regional vision of ending homelessness by providing a housing-focused, equity-driven, and person-centered system of care. By implementing specific strategies such as expanding permanent housing options and providing wrap around supportive services, this project directly supports the regional goals of reducing unsheltered homelessness by 50% and meeting the diverse needs of the homeless population in San Diego. As a result, the Regional Task Force on Homelessness (local CoC) has provided a letter of support for the proposal.

### **Centering People**

10. Describe how the perspectives of people with lived experience of homelessness meaningfully contributed to the content of this proposal? How will people with lived experience be part of the implementation of this ERF project? If individuals living in the encampment site were included in the development of this proposal, describe how their input was obtained and how that input

#### shaped the proposal. (1000-character limit)

The proposal was significantly influenced by the input of individuals who have experienced homelessness firsthand and live in the prioritized area. Outreach workers conducted direct surveys in the encampment to obtain valuable insights into the services that would be most beneficial to residents. Through the surveys we learned that transportation is a major challenge and people have issues meeting their basic needs. We also heard that more storage for possessions is needed more income opportunities and housing options including shared housing. These gaps are all being addressed in the proposal. Peer support will be utilized as a main component of the encampment strategy and hiring of people with lived experience will be prioritized. The program will embed various opportunities for individuals in the encampment to provide on-going feedback including through peer support and regular resource events which will foster ongoing engagement and gather additional feedback.

# 11. Briefly describe how the proposal exemplifies Housing First approaches as defined in Welfare and Institutions Code section 8255. (1000-character limit)

The cities of Oceanside and Carlsbad work to find immediate housing access without preconditions, embodying the principle that housing is a fundamental right. The program uses a strengths-based approach which does not screen out participants on the basis of rental history, credit, or criminal histories, sobriety, income, completion of treatment, participation in services, etc. Support services are unconditional, fostering long-term stability and independence. This person-centered approach respects individual choices and needs. We remove traditional barriers to housing entry, such as sobriety or income requirements. Continuity of care is emphasized, if someone leaves or disengages from services, when they return, they are welcomed back without punitive measures. Complementing this, the City of Oceanside's resolution on May 22, 2022, ensures adherence to Housing First principles even when delegating tasks to third parties, affirming our community-wide commitment to these methods.

# 12. Describe how each of the following service delivery practices are incorporated into the outreach, interim shelter (if applicable), and permanent housing aspects of the proposed ERF project: (a) individual participant choice and (b) trauma informed care. (1000-character limit)

Both cities have implemented Housing First principles, which prioritize participant choice at every step. This is detailed in the cities' resolution concerning homelessness services (Doc # 22-D0795a-1). The cities are committed to maintaining a Trauma-Informed System, which is crucial for enhancing service delivery. This approach involves understanding the impact of trauma, ensuring safety, and being aware of cultural and individual differences. It prioritizes individual empowerment, choice, and independence, and incorporates client input in policy and procedure development. The system minimizes re-traumatization, promotes safety, self-care, and resilience. Participants work with outreach, shelter, and housing staff to create individualized support plans based on their choices and preferences. Both trauma-informed peer and clinical support will be provided. Motivational interviewing will be used, and law enforcement officers are not part of the encampment engagement strategy.

13. Describe how harm reduction principles will be incorporated into the outreach, interim housing (if applicable), and permanent housing aspects of this ERF project. (1000-character limit)

The program's harm reduction model aims to collaborate with participants to identify methods to minimize the harm of a particular behavior if the individual is unwilling or unable to abstain. All individualized support plans include personal harm reduction strategies and are regularly updated as needed. Street medicine (SM) will be provided within the encampment to improve health outcomes as well as substance abuse education, counseling, and referral, focusing on harm reduction practices and strategies. Outreach teams have reported a high incidence of fentanyl use in the encampment, which causes delayed healing of open wounds and is a prevalent issue. SM will provide respectful wound care multiple days a week to assist people in healing. All contractors are required to complete annual training in harm reduction and employ harm reduction strategies in all interactions. This harm reduction model will be used in all services, including outreach, shelter, and housing services.

# 14. Describe the services that will be provided to improve people's health, dignity, and safety while they continue to reside within the prioritized encampment site. (1000-character limit)

The priority location of the encampments is an isolated embankment and creeks that can pose significant safety threats. These include exposure to extreme temperatures and weather, wildlife, and other natural dangers associated with living outside and flood overflow zones. The proposed programs aim to address environmental risks by providing essentials for weather protection to enhance health, dignity, and safety at the encampment. Our street medicine team will tackle health issues, including wound care, particularly for fentanyl users. Mental health and substance abuse support will be available. Personalized harm reduction strategies will be incorporated into support plans, focusing on individual safety. Continuous engagement with residents ensures their voices guide our trauma-informed approach, empowering them within the encampment.

15. Identify what controls are or will be in place to ensure that all ERF-3-R funded parties will not penalize homelessness. The term "penalize homelessness" means to impose, by a governmental unit, criminal or civil penalties on persons who are homeless in a manner that is related to those persons' engagement in necessary human activities, including sleeping, resting, and eating. (1000-character limit)

Under ERF-3-R, Oceanside, and Carlsbad have adopted comprehensive strategies to ensure homelessness is not penalized. Oceanside amended its ordinance, focusing on supportive police engagement, respectful property management with a clear storage/removal process, and ensuring emergency shelter offers. This approach emphasizes humane treatment and resource connection. Carlsbad's Homelessness Action Plan complements this by prioritizing housing solutions, coordinating with law enforcement to address criminal behavior without criminalizing homelessness. The program will connect the unhoused with Homeless Court to address tickets or other legal barriers people may have. Additionally, by prioritizing housing and reducing people's time unsheltered, we will reduce the chances they have negative law enforcement involvement and the barriers and trauma that this involvement may create. Together, the cities demonstrate a commitment to compassionate support aligning with ERF-3-R objectives.

16. Describe how this proposal considers sanitation services for people residing in the prioritized encampment. This may include but is not limited to non-intrusive, curb-side waste removal and access to clean and available bathrooms. (1000-character limit)

Individuals who are currently homeless within the encampment area are living without access to necessities such as toilet facilities, handwashing stations, showers, and clean drinking water. The cities will work with existing contractors to provide encampment cleanup services to ensure the overall health and sanitation of the encampment areas. The cleaning process will be implemented with ample notice to minimize any inconvenience to the individuals living in the encampment. We will not discard any personal items belonging to the residents. Our outreach staff will distribute hygiene kits containing fundamental necessities. We will continually obtain feedback from the encampment residents throughout the grant period to identify opportunities to improve the overall sanitation of the area.

#### **Part 3: IMPLEMENTATION**

### **Core Service Delivery and Housing Strategies**

17. Describe the proposed outreach and engagement strategy, case management, and / or service coordination for people while they are continuing to reside within the encampment site. Quantify units of service to be delivered including the ratio of staff to people served, frequency of engagement, and length of service periods. (2000-character limit)

The project will adhere to our local CoC's Street Outreach Standards. Multidisciplinary outreach teams will be utilized to address the basic needs of persons living in the encampments. This includes immediate medical attention, hygiene needs, and access to food and water. The outreach worker will engage with clients through continuous motivational interviewing to build trust over time and overcome reluctance to engage in case management or other support. The outreach worker will also use a diversion-focused strategy that involves creative problem-solving techniques to find less expensive interventions than shelter, rapid re-housing, or permanent supportive housing. This approach helps clients understand the cause of their housing crisis, explore possible solutions, and pursue those solutions. Safe alternative options include a negotiated return to their previous housing, short-term accommodation, shared housing, or family reunification.

The project will also support individuals with benefit enrollments and document procurement. Mental health support and substance abuse education, counseling, and referrals will be available within the encampment. At least monthly, case conference meetings will be held utilizing a By-Name List to coordinate multidisciplinary efforts and ensure that creative solutions are pursued, and needs are met. A peer support framework will be used to engage with encampment residents to receive feedback on their wants and needs while advancing their wellbeing.

The staffing ratio for the multidisciplinary team will be, at most, 1 to 25. Outreach will actively attempt to engage with individuals at least once every three days. If participants disengage or disappear, they will be moved to inactive status after 90 days. If they are re-engaged, they will receive support to continue implementing their service support plan without any punitive consequences.

18. Describe the role of Coordinated Entry in the context of this proposal and how Coordinated Entry policies or processes will support and / or hinder the implementation of this proposal. (1000-character limit)

The Coordinated Entry System (CES) is integral to the City of Oceanside's plan to help people experiencing homelessness in San Diego County. However, resources can be restrained since the CES covers the entire region, which poses a challenge to the efficacy of the program delivery. The City has successfully addressed this through Oceanside Housing Authority for referrals through CES for Homelessness dedicated Housing Choice Vouchers. This agreement, through a Memorandum of Understanding (MOU), prioritizes local service providers within the CES. With the help of ERF grant funding, the City of Oceanside aims to expand this coordination with partners to prioritize referrals, streamline services through the CES, and effectively serve those in the priority encampment area. Through this project we will maintain people experiencing homelessness on the Coordinated Entry community queue to provide an opportunity for permanent housing but will not rely on that outcome as the sole housing plan.

# 19. Describe each of the specific (a) interim housing and (b) permanent housing opportunities that will be used to achieve the proposed outcomes of this ERF project. Demonstrate that any ERF-3-R funded interim housing capacity is either non-congregate or clinically enhanced congregate shelter. (2000-character limit)

The project will offer both interim and permanent housing options. Carlsbad provides funding to support the La Posada shelter which currently has 50 beds for homeless men with clinician services. The city is working to expand the shelter to include non-congregate space for women and families. The shelter will set-aside 5 beds per week for encampment residents. The Oceanside Navigation Center offers 50 beds and supportive services onsite. The shelter utilizes a low-barrier, person-centered, and trauma-informed care model. Oceanside plans to set aside five weekly beds for encampment residents. The Oceanside Bridge Housing program offers temporary housing to homeless individuals and has three apartments with 12 beds. It prioritizes Oceanside Housing Voucher holders and provides case management services. The City will allocate three beds for encampment residents. The project will also implement a new Safe Parking Program providing space for 25 vehicles.

Additionally, the cities operate short-term motel shelter programs. Grant funds will increase the number of motel vouchers available providing more non-congregate interim options for encampment residents. All these interim housing options will be available to encampment residents who choose to access shelter. 262 individuals will be served with interim shelter.

Permanent housing will be prioritized by funding a robust rapid re-housing program, enrolling clients in CES, providing PSH, and maintaining homeless dedicated HCVs (and a general homeless preference). Shared housing facilitation will also be provided. All these strategies will be used as housing options. The cities also employ housing navigators and will contract for housing coordinators who maintain landlord connections throughout the region. Oceanside has a landlord incentive program which will be leveraged to increase the incentives for landlords who accept program participants. 196 individuals will transition to permanent housing through this proposal.

20. Demonstrate the applicant's commitment and ability to deliver permanent housing solutions to the people residing in the prioritized encampment, including by providing examples of prior successful efforts to permanently house similarly situated individuals. (2000-character limit)

The cities have shown a solid dedication to implementing a proposal aimed at providing permanent housing solutions to people living in the prioritized encampment. The City of Carlsbad has successfully helped over 250 people transition into permanent housing within the last two years through its Homelessness Action Plan strategies, with a 73% reduction in veteran homelessness. Based on this success, the City received an ERF-2-R grant to tackle another encampment area. The ongoing project is helping individuals in similar situations to end their homelessness.

The City of Oceanside has implemented several housing programs to cater to diverse groups within the homeless population. These programs include Homeless Dedicated Housing Choice Vouchers with specific preferences for different demographics within the homeless population, such as seniors, individuals with mental illness, veterans, and those with disabilities. Additionally, programs such as the Family Unification Program and Emergency Housing Voucher Program are in place to address broader needs.

The programs have been successful in providing permanent housing solutions to encampment residents. Last year, Oceanside permanently housed 194 formerly homeless individuals through these programs, showcasing our capability to provide comprehensive solutions to the homeless population. This track record aligns with ERF project goals and demonstrates our commitment to helping those in need.

## 21. Describe how this proposal is tailored to meet the needs and preferences of people residing within the prioritized encampment. (1500-character limit)

This proposal has been designed to meet the specific requirements and preferences of the residents residing in the selected encampment. The City of Oceanside has followed an all-inclusive approach that prioritizes the community's needs to achieve this goal. Through its outreach teams, the City has conducted extensive interviews with homeless individuals to gather valuable insights that have directly informed the strategies, initiatives, and actions outlined in this proposal.

California Department of Transportation (Caltrans) has expressed support for Oceanside's Encampment Resolution. The partnership shares a vision for a safer, more inclusive community. It demonstrates Caltrans' broader mission to serve all people while respecting the environment and fostering new opportunities for those in need in the encampment area. They supported identifying the pressing needs of encampment residents, including access to non-congregate shelter options, essential medical care, secure storage facilities, easily accessible mail services, housing subsidies, and support with housing procurement. The proposal addresses these service gaps by taking a comprehensive outreach approach to combat homelessness within the encampment. The proposed project will adapt to the residents' needs and use trauma-informed best practices to reduce barriers. The project will strategically allocate grant funding and leverage existing programs to address the evolving needs of individuals in the encampment area.

22. Describe strategies the applicant will use to ensure that people are not displaced from the prioritized encampment into another unsheltered location. Include strategies that are in addition to/complement the interim shelter and permanent housing opportunities that are part of this proposal. (1000-character limit)

The encampment resolution strategy within the City of Oceanside is entirely centered around utilizing a multidisciplinary team model to facilitate connections for individuals with various housing pathways. Enforcement is not a component of this strategy and close coordination with the local police will be maintained. This approach prioritizes consistent outreach and engagement efforts, expediently linking participants to diverse low-barrier interim and permanent housing options.

Participants will receive comprehensive wrap-around supportive services designed to address their health and safety concerns. These services include providing a street medicine team, support for substance abuse and harm reduction, assistance with mental health challenges, sanitation facilities, and resources for storage and pets. The delivery of these services will take place directly at the encampment location and will be tailored to individual needs, guided by a person-centered approach.

23. Describe specific strategies and/or services the applicant will use to prevent returns to unsheltered homelessness among people from the prioritized encampment who are sheltered and housed through this ERF project. Include whether these strategies will be funded with ERF-3-R funds and, if not, what other resources will be leveraged. (1000-character limit)

As people move into interim shelter or housing options, they will continue to receive supportive services to prevent returns to unsheltered locations. The La Posada Shelter, Oceanside Navigation Center, and Oceanside Bridge Housing Program have onsite services available which will be leveraged. Participants placed into motels will receive daily support from ERF-3-R funded multidisciplinary teams. The housing stability support in permanent housing will depend on the housing utilized. Placements through CES will have program supports. Participants using rapid re-housing, shared housing, or leveraged vouchers will receive support from Community Resource Center's ERF-3-R funded case managers. Strength-based housing stability plans will be designed to help reduce barriers to maintaining housing using an intensive case management or critical time intervention model. Leveraged prevention will be available as needed and connections to community supports and healthcare will be prioritized.

## 24. Describe how this proposal considers and plans for the dynamic nature of encampments including potential inflow of people into the geographically served areas. (1000-character limit)

We understand that the encampment area is not static, and people will move from the area and come to the area after the project has started. To address the dynamic nature of encampments, our proposal includes coordinated strategies with partner agencies for real-time response. We'll use coordinated outreach, a By-Name List, and case conferencing for monitoring and adapting to changing encampment populations. The By-Name List will be generated from the HMIS in coordination with the CoC. All partner agencies (outreach, shelter, housing) will contribute to the list and participate in case conferencing using a multidisciplinary approach to client support. The By-Name List process of addressing homelessness within the encampment area provides an effective framework for the dynamic nature of the prioritized encampment and allows the partners to better understand and meet the needs of a diverse and changing population.

# 25. Describe how participants in this ERF project will be supported with continued access to, and storage of, their personal property while in the encampment, in interim housing (if applicable), and in permanent housing. (1000-character limit)

In our ERF project, ensuring the safety and accessibility of personal property is a priority. The feedback we have received from those with lived expertise identifies the lack of storage access for personal property as an issue within the encampment. As a result, we've partnered with a local storage company, experienced in assisting the unhoused, located near the encampment. This collaboration will allow us to provide funded leases for individual storage units. These units will be available to participants for storing their belongings securely as they transition from the encampment to interim or permanent housing. This approach respects the importance of personal property and facilitates a smoother transition for individuals into stable living conditions.

26. Describe how participants in this ERF project who have service animals and/or pets will be supported while in the encampment, in interim shelter (if applicable), and in permanent housing. (1000-character limit)

The project recognizes the significance of service animals and pets to our participants. Both Cities have a contract with the San Diego Humane Society to provide safe pet boarding during temporary separations. The Humane Society also conducts wellness checks and offers pet food in encampments. The Navigation Center and La Posada de Guadalupe shelter has lowered restrictions to allow pets, ensuring owners can stay with their animals. We will also ensure that people are supported with ensuring their service animals or pets can transition with them into their permanent housing destinations. This person-centered approach reflects our commitment to the well-being of program participants and their animal companions throughout the transition from encampment to shelter and permanent housing.

We plan to leverage various programs and grants to support our proposal's objectives of enhancing housing stability and addressing homelessness. This includes supervision for outreach, the La Posada Shelter, and RRH; HCV staff; clinician services at La Posada; and benefit services. This is expected to be over \$3.3 million in leveraged personnel. We will also leverage funding for the Oceanside Navigation Center, Oceanside Bridge Housing, motel vouchers, pet boarding, shelter expansion, prevention assistance, reunification assistance, rapid re-housing, permanent rental assistance, and landlord incentives. This is about \$8.9 million in leveraged funds. In total we expect to directly leverage over \$12 million in funding. Indirect leverage will include food assistance through CalFresh and housing subsidies and services through the Coordinated Entry System (CES). Throughout the project the cities will continue to identify systems and funding that can be leveraged to support participants.

The proposal utilizes evidence-based interventions and best practices to ensure that the funding is used effectively to serve the number of people projected. The average ERF costs per participant is projected to be about \$32,567. However, studies of the annual cost of someone remaining homeless have ranged from \$35,000 (nationally) to \$120,000 (highest locally) per year. This does not include the personal trauma and community impacts related to homelessness which are more difficult to quantify but significant. The project uses funding to connect with individuals, re-house them and then provide the support they need to maintain housing. The amount of funding requested was determined based on the identified funding gaps needed to address the unsheltered homelessness in the encampment area. We have made investments in addressing homelessness and the funding requested is designed to fill gaps to meet the high service needs of the people in the encampment area and not supplant other funding

This project will be implemented as a partnership between the City of Oceanside and the City of Carlsbad through a Memorandum of Understanding (MOU). The City of Oceanside will be the grant administrator and fiscal agent through its Housing and Neighborhood Services Department. The City of Oceanside has extensive experience in managing complex funding for homelessness. One prime example of this is the Section 8 Housing Choice Voucher (HCV) program, which has been operational in Oceanside since 1982. The program offers rental assistance to low-income households, including those who are homeless.

The City of Oceanside is committed to addressing the area's homelessness issue. In program services and housing resources, the City of Oceanside has dedicated \$3,135,000 to support projects specifically targeting individuals experiencing permanent homelessness. Additionally, the City of Oceanside will provide in-kind service contributions of \$1,100,000 annually to support the development, implementation, and ongoing services of the Housing Choice Voucher Program. The city will dedicate 1.5 FTEs to overseeing grant administration and operations.

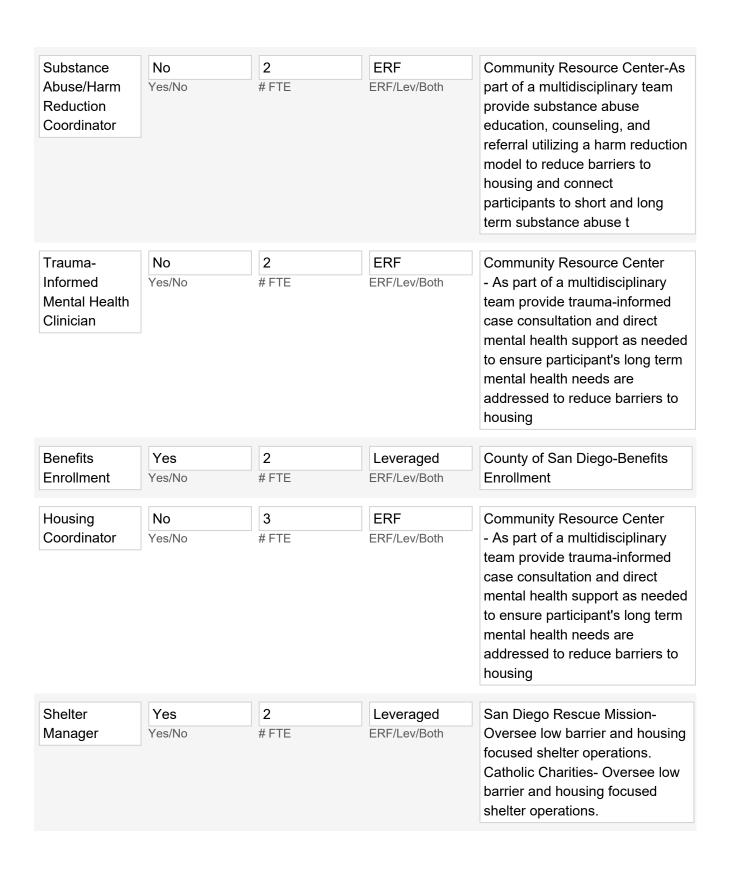
The City of Carlsbad Housing & Homeless Services Department (HHS) Homeless Services Division implements the city's Homelessness Action Plan and oversees a homelessness budget of over \$6 million per year. The city will dedicate .5 FTE to oversee grant implementation, coordination, and contract administration.

The key partners' collective efforts will achieve the outcomes of this proposal. The City of Oceanside will coordinate all grant activities, performance monitoring, reporting, fiscal oversight, and establishing an MOU to outline roles and responsibilities through the grant term. The partners below are highly competent in managing complex projects and grant applications serving persons experiencing homelessness through local, state, and federal funding sources. Their expertise in this area has informed the strategies and oversight of this grant application and processes.

- The City of Carlsbad will coordinate street medicine, mental health, substance abuse, and housing administration.
- San Diego County will provide mainstream benefit outreach and enrollment.
- Interfaith Community Services will administer motel vouchers and storage assistance.
- Community Resource Center specializes in substance abuse, mental health services, and housing solutions.

Each partner's track record in managing complex homelessness initiatives informs our approach, ensuring a comprehensive, experienced-led project.

The cities of Oceanside and Carlsbad have a long history of working closely with the Regional Task Force on Homelessness (RTFH Both cities are active members of the CoC's Full Membership program, and Oceanside's Housing Director serves on the CoC's Board. The CoC's Local Government Liaison was consulted and helped to inform the development of this proposal. Additionally, we have received a letter of support from the CoC expressing their continued commitment and desire for the partners to be awarded funding. This collaborative relationship demonstrates the cities' strong commitment to addressing homelessness in the region.

The proposal is aligned with the Regional Community Action Plan to Prevent and End Homelessness in San Diego, with a specific focus on the "People Goal" of reducing the percentage of individuals experiencing unsheltered homelessness throughout the region by 50%. This collaborative effort is consistent with RTFH's mission to reduce and end homelessness in San Diego.

The prioritized encampment area is on public property controlled by the cities of Oceanside, Carlsbad, and Caltrans. All entities have agreed to support and participate in this project. The City of Oceanside will oversee this grant and is committed to implementing this proposal. We understand that cross-system collaboration will be crucial and have partnered with non-profits who have experience assisting people experiencing homelessness with a range of service needs. Many staff members are already in place for project implementation, and the partners will be holding joint recruiting, hiring, and training events to ensure that knowledgeable staff members are added to the team. The collaboration of the key partners, guided by the coordination of the Cities of Oceanside and Carlsbad, will provide the capacity necessary to carry out this proposal.

# 35. How is your community currently supporting and / or engaging with people residing within the prioritized encampment? (1000-character limit)

The cities are currently using existing resources to engage and support people residing in the prioritized encampment as available. However, additional resources are needed as services are at capacity and additional barriers are being identified that are preventing people from moving towards housing and stabilization. The partners want to act urgently and efficiently in addressing these needs.

Encampment residents were surveyed by outreach workers and the proposal herein specifically addresses many of the reported barriers including access to mail services, storage, rental assistance, and other support in reducing barriers to housing. This provides the foundation for the partners to act quickly once the grant is awarded so that we can improve housing outcomes in the encampment while continuing to prioritize the dignity, safety and wellness of people experiencing homelessness within the encampment site.

# 36. If this proposal is selected, in advance of receiving funding, what steps will your community take to support the people living in the encampment and swift implementation of this proposal? (1000-character limit)

Both Cities are in close collaboration with key partners and can rapidly mobilize. The strategic framework is currently in place as well as existing contractual relationships which will be leveraged to implement services quickly. This groundwork ensures seamless cooperation between government entities and expedites the deployment of resources. After award notification the City of Oceanside will quickly take the item to the City Council to approve the award and contract with the state, while also working to implement the MOU and other contracts. The partners will start the recruitment process for new staff members immediately upon award notification. This will allow us to quickly start to implement the proposal once the contract is executed with the state. The experience of the cities coordinating homelessness contracts and initiatives, and their commitment as the proposal leads, will ensure that the proposed milestones and objectives will be met.

The California Department of Transportation (Caltrans) District 11 is supportive of and committed to the City of Oceanside for their proposal of the Encampment Resolution Funding Request (ERF). The City of Oceanside has been providing services such as outreach, general relief, Cal-fresh, emergency shelters, permanent housing, COVID and flu vaccinations along State Route 005 and 076 for the last 20 months. We know they are committed to the region and have shown their willingness in partnering to improve the accessibility of those most in need by providing housing and other resources.

Caltrans supports ERF funding for the City of Oceanside for the following reasons:

If funded, SDRM looks forward to partnering with the City of Oceanside and providing outreach services. Specifically, as a homeless service provider, SDRM will use a relational approach and follow the community standards outlined by the Regional Task Force on Homelessness, our region's Continuum of Care (CoC). SDRM utilizes the Homeless Management Information System (HMIS) and the Coordinated Entry System (CES) to help facilitate the resolution of a person or family's homelessness. In addition, SDRM has a shower trailer and access to beds in our shelter and long-term program. SDRM's professional acumen in homeless services has positioned the organization to be a strategic partner in meeting the needs of the community.

The work we would provide will mirror the work we currently do with the Little Italy Association. We provide daily outreach services utilizing the above mentioned approach. Our goal is to help people transition to housing and better connect to services. We provide monthly reporting and track outcomes. Over the course of a year, we were able to help 64 people leave the streets and get into housing or programing that will help end their homelessness. The Oceanside and Carlsbad ERF-3-R proposal is a crucial initiative aligned with the Regional Community Action Plan to Prevent and End Homelessness in San Diego. Specifically, it aims to achieve the goal of reducing the percentage of people experiencing unsheltered homelessness throughout the region by 50%.

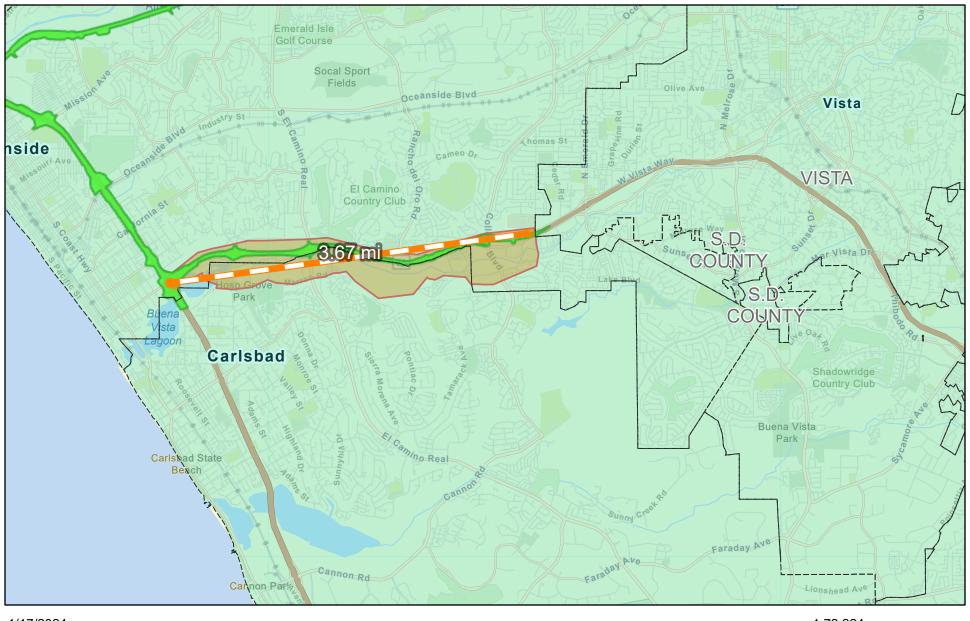
Both Oceanside and Carlsbad have a commendable track record of addressing homelessness through collaborative efforts, actively participating in the Regional Task Force on Homelessness as long-standing members of the Continuum of Care's Full Membership.
