All jurisdiction allocations are based on the 2023 PIT counts.

*When more than one eligible city is within the same PIT count area, the proportionate share of funds shall be

equally allocated to those cities.

**No more than 45 percent of the total allocation for cities will be awarded to an individual city.

***No more than 40 percent of the total allocation for counties will be awarded to an individual county.

The allocation is the total award amount that jurisdictions are eligible to receive, including the HHAP-5 Base Allocation, the HHAP-5 Planning Allocation, and the \$100 million Supplemental Allocation. The awards will be made in two disbursements: an initial disbursement and a remainder disbursement.
