Roles & Responsibilities

Visalia/Kings, Tulare Counties CoC

Visalia/Kings, Tulare Counties CoC maintains five (5) Housing Navigators who conduct street outreach to people experiencing homelessness in Kings and Tulare Counties, including two (2) Housing Navigators who work specifically with the City of Tulare's Encampment Resolution Project, one (1) who works specifically with Kaweah Health on the development and implementation of a Street Medicine program, one (1) who works specifically in Kings County, and one (1) who works specifically in Tulare County. Housing Navigators work with clients to get them document-ready for the available housing programs.

Visalia/Kings, Tulare Counties CoC hosts various monthly case conferencing meetings with outreach staff from around the region to coordinate outreach efforts and ensure no benefits are duplicated.

Visalia/Kings, Tulare Counties CoC works with outreach staff to develop an outreach schedule to ensure full regional coverage, safety, and collaboration across different agencies and jurisdictions.

Visalia/Kings, Tulare Counties CoC hosts weekly or bi-weekly drop-in centers called Local Initiatives Navigation Centers around the Kings and Tulare Counties. These events provide a space where people experiencing homelessness can access multiple service providers in a centralized location. Current events occur in Visalia and Porterville in Tulare County and Hanford and Corcoran in Kings County.

When appropriate, Visalia/Kings, Tulare Counties CoC leadership attends jurisdictional leadership meetings including City Council Meetings and Board of Supervisors Meetings to advocate for the usage of available land for the construction of new affordable housing developments, low barrier emergency shelters, and homeless navigation centers.

Kings County Human Services Agency

The Kings County Human Services Agency is responsible for programs and projects within the unincorporated political boundaries of Kings County. Kings County Human Services Agency works with the incorporated cities on activities that cross city/county jurisdictions. Kings County Human Services Agency is part of the Kings County Homelessness Collaborative. Kings County Human Services Agency works closely with various community providers to improve access to services, identify needs, and braid funds where programmatic goals align. The Kings County Homelessness Collaborative (KCHC) is currently evaluating all outreach activities and processes to expand outreach efforts. The Kings County Homelessness Collaborative aims to include more service partners using the geographic information system (GIS). The GIS will enable targeted assistance to deliver services and provide a standardized method for connecting the homeless population to programs that best address their needs. This will maximize the use of CalAIM.

Tulare County Human Services Agency

Tulare County works with incorporated and unincorporated areas within our jurisdiction and collaborates closely with Visalia/Kings. Tulare Counties CoC on all activities. Our Community Coordination Team ("CCT") engages in direct encampment outreach and collaborates with shelter sites such as navigation centers, homeless shelters, temporary housing, and interim housing sites. The CCT participates in case management roundtables, jurisdictional efforts with Encampment Resolution Funding, street medicine providers, and other street outreach teams. Our CCT is also a CalAIM ECM provider. The CCT coordinates street outreach with other service providers such as Kings View PATH, Street Med., Salt + Light Works, Visalia/Kings, Tulare Counties CoC through Homeless Management Information System, the Coordinated Entry System, and Visalia/Kings, Tulare Counties CoC Case Management Roundtable Meetings.

Given the individual roles and responsibilities identified above, describe and explain how all participating jurisdictions are or will begin to coordinate these efforts to ensure comprehensive outreach and site coordination to individuals experiencing and at-risk of experiencing homelessness in the region.

Regional Coordination Narrative - Outreach & Site Coordination

Visalia/Kings, Tulare Counties CoC, Tulare County Health and Human Services Agency, and Kings County Human Services Agency work closely on collaborating outreach efforts and site coordination in Kings and Tulare Counties.

Visalia/Kings, Tulare Counties CoC's Housing Navigators work closely with Kings County Human Services Agency and Tulare County Health and Human Services Agency staff to coordinate outreach efforts and

ensure full regional coverage. Visalia/Kings, Tulare Counties CoC will continue to host monthly Membership Meetings, Case Management Roundtable Meetings, and Case Conferencing Meetings. Kings County Human Services Agency and Tulare County Health and Human Services Agency are actively involved in all of these meetings by regularly providing training, offering comments, and participating in case conferencing. Additionally, Kings County Human Services Agency and Tulare County Health and Human Services Agency send representatives from their respective outreach teams to Local Initiatives Navigation Center events to provide outreach services to people experiencing homelessness.

Visalia/Kings, Tulare Counties CoC also has an Executive Director act as a voting member at both the Kings County Homeless Collaborative and the Tulare County Homeless Taskforce, where system-wide change is discussed and implemented.

Tulare County has adopted a strategic plan titled Pathway Home, which serves as a guiding document for our efforts. We also coordinate a monthly Homeless Task Force meeting which includes representation from multiple jurisdictions, sectors, and individuals with lived experience. Tulare County participates in Visalia/Kings, Tulare Counties CoC meetings and initiatives such as Membership Meetings, LINC events, Point in Time, and participates in the Homeless Management Information System ("HMIS").

The Kings County Human Services Agency (HSA) has a strong partnership with the Visalia/Kings, Tulare Counties CoC. This partnership has led to collaboration on a gap analysis for Kings County's homeless population. Visalia/Kings, Tulare Counties CoC also conducts the yearly Point in Time (PIT) count, which includes Tulare County's homeless population. The PIT count has allowed for a bridge between the two counties to address the needs of the homeless residents. The formation of the homeless action plan has allowed for a close working relationship with all three parties to work towards the common goals of our region.

Land Use & Development

Roles & Responsibilities

Agency

Tulare County Resource Management The Tulare County Resource Management Agency's ("RMA's") branches include Public Works (engineering), and Economic Development and Planning. Public Works responsibilities include engineering design, infrastructure construction, and water/sewer facilities management. Economic Development and Planning oversees land use and zoning permits, environmental planning/permitting, building permits and inspections, and code enforcement, and manages dairies, mining, timber, and water resources, including a \$ 60 million in grant portfolio for the County's resources. RMA includes four Commissions for Planning, Water, Agriculture, and Flood Control.

> On January 31, 2024, Gov. Newsom announced that Tulare County had received our Prohousing designation with 43 points out of 30 points, as one of 6 California Counties, for Tulare's ability to get projects entitled and built efficiently, with limited fees, and with numerous incentives. The County recently made several zoning regulatory changes to make permanent and interim supportive housing easier and with more incentive bonuses than the state requires.

RMA participates with the Tulare Countywide Homeless Task Force ("HTF") and partners in our Roomkey and Homekey

projects. They oversee CDBG and PLHA funds. Homeless Housing Assistance and Prevention funds are overseen by the Tulare County Health & Human Services Agency. RMA prioritizes Homekey Housing Projects for building permits, California Environmental Quality Act (CEQA), National Environmental Policy Act (NEPA), and land use planning findings and permits. Our agencies have successfully collaborated on several projects and initiatives.

Visalia/Kings, Tulare Counties CoC

Visalia/Kings, Tulare Counties CoC is the owner of Sunrise Apartments (previously Stardust Motel), a Homekey project in Kings County, which has received supplemental funding via Homeless Housing Assistance and Prevention Rounds 1 and 3. Upon completion of the construction, ownership will transfer to Kings Community Action Organization, a community partner.

Visalia/Kings, Tulare Counties CoC works closely with the developers RH Community Builders, Self-Help Enterprises, and UpHoldings to build new affordable housing developments in Kings and Tulare Counties.

Kings County Human Services Agency

Land use and development fall outside HSA's scope of work. However, Kings County Human Services Agency has helped fund developmental projects such as Sunrise Apartments (Stardust) and Triangle Courtyard via Homeless Housing Assistance and Prevention Rounds 1-3. Kings County Human Services Agency works closely with Kings/Tulare Homeless Alliance, Cornerstone, and Upholdings for these projects.

Given the individual roles and responsibilities identified above, describe and explain how all participating jurisdictions are or will begin to coordinate these efforts to use and develop available land to address and end homelessness in the region.

Regional Coordination Narrative - Land Use & Development

These discussions occur via the monthly Visalia/Kings, Tulare Counties CoC Membership Meetings, Kings County hosts monthly Homeless Collaborative meetings, and Tulare County hosts monthly Homeless Task Force meetings. All three entities collaborate and coordinate through these monthly meetings as well as via topic-specific ad hoc meetings. Representatives attend City Council meetings and county Board of Supervisor meetings to advocate for land use and housing development. Most development takes place via independent organizations that partner with our organizations. Kings Community Action Organization is engaged in Sunrise Apartments (previously Stardust Motel); the agency will take over ownership from Visalia/Kings, Tulare Counties CoC upon the completion of construction. Tulare County representatives have worked with city jurisdictions and the Tulare County Resource Management Agency ("RMA") to participate in the development of their Housing Elements. The Tulare County RMA obtained a Prohousing designation as announced by Gov. Newsom on Jan. 31, 2024./

Visalia/Kings, Tulare Counties CoC, who manages the local Coordinated Entry System, will continue to partner with developers to bring affordable housing to the bi-county region. The following developments have opened in the last year: Sequoia Village (Tulare County), Finca Serena (Tulare County), Palm Terrace II (Tulare County), Santa Fe Commons II (Tulare County), Sierra Village II (Tulare County), The Lofts (Tulare County), Sequoia Commons II (Tulare County). The following developments will open in

2024: Madson Gardens (Tulare County), Triangle Courtyard (Kings County), Northstar (Kings County), Sunrise Apartments (Kings County), Neighborhood Village (Tulare County). Combined this will bring a total of almost 250 affordable housing units that are set aside for Coordinated Entry referral. Visalia/Kings, Tulare Counties CoC will work closely with Kings County Human Services Agency and Tulare County Health and Human Services Agency to identify eligible clients to move into available units as the developments open.

The Bridge Program in Kings County will be managed by the Kings Community Action Organization. The program will offer 27 units at the Holiday Lodge to eligible individuals. Participants must be diagnosed with a mental health condition/disorder, with priority being given to individuals who are coming from Care Court. The Bridge program is scheduled to begin on June 25, 2024.

Development of Interim and Permanent Housing Options

Participating Jurisdictions

Roles & Responsibilities

Visalia/Kings, Tulare Counties CoC

Visalia/Kings, Tulare Counties CoC works to increase the amount of Permanent Housing options through United States Department of Housing and Urban Development (HUD) by partnering with service providers to apply for expansions of their current Permanent Housing projects or new projects. Visalia/Kings, Tulare Counties CoC aims to apply for all available renewal and bonus funds every year through HUD's Continuum of Care competition. Additionally, Visalia/Kings, Tulare Counties CoC engages the Housing Authority of Kings County and the Housing Authority of Tulare County to request additional housing vouchers from HUD and/or recapture unused vouchers from other communities.

Visalia/Kings, Tulare Counties CoC submits the annual Emergency Solutions Grant Balance of State application that funds a Rapid Rehousing project in Kings and Tulare Counties.

Visalia/Kings, Tulare Counties CoC partners with City of Tulare on their Encampment Resolution Project (funded through Encampment Resolution Funding Rounds 1 and 2) which provides Rapid Rehousing to people experiencing homelessness in the designated encampment area. Visalia/Kings, Tulare Counties CoC wrote a letter of support for the Encampment Resolution Project and was a subrecipient of the funding which was used to hire two (2) Housing Navigators and one (1) Transportation Liaison.

Visalia/Kings, Tulare Counties CoC also wrote a letters of support for two Encampment Resolution Project Round 3 applications: Kings Community Action Organization's Encampment Resolution Project in the City of Hanford, which includes funds for rental assistance for individuals living in the designated encampment area, and the City of Visalia's Encampment Resolution Project.

Additionally, Visalia/Kings, Tulare Counties CoC is supporting multiple agencies and jurisdictions in the development and

construction of emergency shelter/navigation centers in Kings and Tulare Counties. The following interim housing projects will be completed during the term of Homeless Housing Assistance and Prevention Round 5: Hanford Navigation Center (200 shelter beds), Porterville Emergency Shelter (up to 90 shelter beds), Tulare Navigation Center (500 shelter beds), and Visalia Navigation Center (150 shelter beds).

Visalia/Kings, Tulare Counties CoC partners with housing developers to support the conversion and/or construction of facilities to permanent housing units. The following will be completed from 2023-2025: Sequoia Village (Tulare County), Finca Serena (Tulare County), Palm Terrace II (Tulare County), Santa Fe Commons II (Tulare County), Sierra Village II (Tulare County), The Lofts (Tulare County), Sequoia Commons II (Tulare County), Madson Gardens (Tulare County), Triangle Courtyard (Kings County), Northstar (Kings County), Sunrise Apartments (Kings County), Neighborhood Village (Tulare County). Combined this will bring a total of almost 250 new affordable permanent housing units that are set aside for individuals experiencing homelessness.

Kings County Human Services Agency

Kings County Human Services Agency has helped fund developmental interim and permanent housing projects such as Project Room Key, Sunrise Apartments (Stardust), and Triangle Courtyard. Kings County Human Services Agency works closely with Kings/Tulare Homeless Alliance, Cornerstone, and Upholdings for these projects. The Room2Home was established to temporarily house individuals until the completion of the permanent housing project: Homekey Triangle Courtyard.

Tulare County Health & Human Services Agency

HHSA works closely with jurisdictions within our county, community-based organizations, and developers to determine projects and any available support. We dedicated ARPA, Homekey, and Homeless Housing Assistance and Prevention funds to support the development of housing sites such as Sequoia Village (HK1 site), Madson Gardens (HK2 site), a tiny home village titled Neighborhood Village developed by a local non-profit, shelter support, the development of Navigation Centers, and affordable housing such as Finca Serena in Porterville. We will continue to work with partners to identify viable projects and potential support the County of Tulare can provide.

Agency

Tulare County Resource Management If within the unincorporated County, RMA allows transitional, permanent, and emergency supportive housing in all residential zones and in zones containing the "mixed-use" overlay designation. In other zoning districts, RMA would be required to make findings that allow supportive housing such as in the commercial and industrial zones. In agricultural zones, this may require changing the zoning or the utilization of a use permit approved by the Planning Commission. RMA would process the building permits and make them a priority to complete them as

timely as possible and within the guidelines of the grant funding. RMA also assists in the inspection of demolition and building inspection of facilities.

Given the individual roles and responsibilities identified above, describe and explain how all participating jurisdictions are or will begin to coordinate these efforts to develop adequate interim and permanent housing options to address and end homelessness in the region.

Regional Coordination Narrative - Shelter, Interim, and PH Options

Visalia/Kings, Tulare Counties CoC meets bi-monthly with our Housing and Urban Development (HUD) representative to discuss the options available to increase the amount of Permanent Supportive Housing funding to Kings and Tulare Counties. As part of the annual HUD Continuum of Care competition Visalia/Kings, Tulare Counties CoC works with agencies to apply for bonus funds to increase the number of available Permanent Supportive Housing beds. In the 2023 HUD Continuum of Care competition a Kings County project increase the number of Permanent Supportive Housing beds by 10. During the HUD grant application, we work closely with Kings County Human Services Agency and Tulare County Health and Human Services Agency on identifying new projects that may be interested in applying for new and/or bonus funding.

Visalia/Kings, Tulare Counties CoC is also working with the Housing Authority of Kings County and the Housing Authority of Tulare County to increase the number of Emergency Housing Vouchers ("EHV" - these vouchers are currently being used but the allocation is exhausted), Housing Choice Vouchers ("HCV"), Mainstream Vouchers ("MVP"), Move-up Vouchers (allocated before the "Move-On" vouchers were released) available. Visalia/Kings, Tulare Counties CoC actively coordinates and collaborates with the Housing Authority of each county to maximize access to existing vouchers and advocate for additional allocations. Discussions regarding the voucher increases occur at both the Kings County Homeless Collaborative and the Tulare County Homeless Taskforce, which Kings County Human Services Agency and Tulare County Health and Human Services Agency lead and/or actively participate in.

As the bi-county CoC, Visalia/Kings, Tulare Counties CoC also submits the Emergency Solutions Grant Balance of State application that funds one of our local Rapid Rehousing programs through the Salvation Army. Kings County Human Services Agency and Tulare County Health and Human Services Agency provide social safety net services to meet the potential needs of our clients who could benefit from Rapid Rehousing.

Additionally, Visalia/Kings, Tulare Counties CoC is working on increasing the number of interim housing options by partnering with the City of Tulare on their Encampment Resolution Project (funded through Encampment Resolution Funds Rounds 1 and 2). The project provides rapid rehousing to residents of the designated encampment area. Tulare County Health and Human Services Agency has been a partner on this project by assisting with the funding applications, maintaining the presence of Tulare County Health and Human Services Agency's Community Coordination Team at encampment sites, and coordinating with other service providers to deliver individualized support. Tulare County Health and Human Services Agency has strategically infused funds into shelters, navigation centers, affordable housing, rapid rehousing, and permanent housing. This includes coordinating with Tulare County Health and Human Services Agency's social safety net programs across our branches including Human Services, Behavioral Health, and Public Health.

Visalia/Kings, Tulare Counties CoC is supporting Kings Community Action Organization's Encampment Resolution Funding Round 3 application by writing a letter of support. If awarded funding, Visalia/Kings, Tulare Counties CoC will partner with Kings Community Action Organization by provide housing navigation services at the identified encampment. Kings County Human Services Agency also anticipates partnering with this project by providing on-site services to encampment residents.

Visalia/Kings, Tulare Counties CoC, Kings County Human Services Agency, and Tulare County Health and Human Services Agency work collaboratively to support the development of new affordable housing facilities in Kings and Tulare Counties by providing funding, participating in lease-up meetings, and providing on-site services once individuals have moved into the units.

These discussions occur via the monthly Visalia/Kings, Tulare Counties CoC Membership Meetings, Kings County hosts monthly Homeless Collaborative meetings, and Tulare County hosts monthly Homeless Task Force meetings. All three entities collaborate and coordinate with their local groups through these monthly meetings. Each county's Housing Authority holds a voting member position on the respective homeless collaborative/taskforce. Kings County Human Services Agency will work closely with Visalia/Kings, Tulare Counties CoC to identify eligible clients to move into available units as the developments become available.

Coordination of & Connection to Service Delivery

Visalia/Kings, Tulare Counties CoC	Visalia/Kings, Tulare Counties CoC hosts the following coordination meetings: Kings County Service Provider Forum, monthly bi-county Case Management Roundtable Meeting, and monthly Membership Meetings. During both the Kings County Service Provider Forum and the Bi-County Case Management Roundtable Meeting front-line staff meet to discuss challenges and services available to people experiencing homelessness. The monthly Membership Meetings rotate quarterly between Training Meetings which offer a wide variety of training topics to partner agencies (topics include CalAIM 101, LGBTQ 101, Cultural Humility, etc.), Community Stakeholder meetings that are open to all members of the community and tend to give updates on the homeless response system and highlight a new agency/project, and Executive Meetings that are geared towards partner agency and jurisdictional leadership where system-wide topics are discussed. Additionally Visalia/Kings, Tulare Counties CoC hosts regularly scheduled Local Initiative Navigation Center events across the bi-county region. These drop-in centers allow for individuals experiencing homelessness to access multiple service providers at one time in a centralized location.
Kings County Human Services Agency	Host monthly Kings County Homelessness Collaborative meetings with all jurisdictions within Kings County, community organizations, including those with lived experience.
Tulare County Health & Human Services Agency	Host monthly Countywide Homeless Task Force (HTF) meetings including all jurisdictions within Tulare County, community organizations, and other representatives including those with lived experience. Participate in LINC events, and other Visalia/Kings, Tulare Counties CoC hosted meetings and forums. Act as a Voting Member in the Visalia/Kings, Tulare Counties CoC membership.

Given the individual roles and responsibilities identified above, describe how all participating jurisdictions are or will begin to coordinate to provide the full array of services, shelter, and permanent housing solutions to people experiencing and at-risk of experiencing homelessness in the region.

Regional Coordination Narrative - Coordination & Connection to Service Delivery

Visalia/Kings, Tulare Counties CoC partners with both Kings County Human Services Agency and Tulare County Health and Human Services Agency for Local Initiative Navigation Center events. Both counties sends service provider staff to the events to offer a wide variety of services to people experiencing homelessness including Supplemental Security Income/Social Security Disability Insurance services, CalFresh, and notary services. Kings County Human Services Agency and Tulare County Health and Human Services Agency also advertise Local Initiative Navigation Center events to spread the word about the services being offered.

Visalia/Kings, Tulare Counties CoC hosts monthly Case Management Roundtable Meetings where case managers, service providers, and outreach staff come together to review referrals, discuss best practices, and receive training. Kings County Human Services Agency and Tulare County Health and Human Services Agency send representatives from their respective service provider teams to these meetings.

Visalia/Kings, Tulare Counties CoC hosts monthly service coordination meetings in Kings County, in partnership with Kings County Human Services Agency. These meetings are an opportunity for Kings County service providers to network, have case conferences, and learn about what services are available for their clients.

Kings County Human Services Agency and Visalia/Kings, Tulare Counties CoC are members of the monthly Homelessness Collaborative Meetings to advise and assist Kings County's efforts to address homelessness issues affecting the community and come together to identify services and recommend strategies, goals, and funding resources to address homelessness.

The Tulare County Human Services Agency hosts monthly meetings of the Countywide Homeless Task Force ("HTF"). We also participate in Visalia/Kings, Tulare Counties CoC meetings and Local Initiatives Navigation Center events. Through these forums, we established our strategic plan titled, "Pathway Home: Responding to Homelessness in Tulare County" which was adopted by our partners and jurisdictions. This document has been our guide for collaboration and cohesive action including developing housing, shelter, and street outreach opportunities. Tulare County Human Services Agency has a branch called Integrated Services which is coordinating our agency's CalAIM efforts and has implemented a team called the Community Coordination Team ("CCT"). This team conducts direct street outreach, supports the efforts of our jurisdictions that have received Encampment Resolution Funding, attends Local Initiative Navigation Center events, and works to integrate access to services from across the vast array of programs and services Tulare County Human Services Agency offers.

Visalia/Kings, Tulare Counties CoC works closely with the City of Tulare on their Encampment Resolution Funding (ERF) project. Visalia/Kings, Tulare Counties CoC is under contract with the City to utilize funds to hire one FTE Housing Navigator under Encampment Resolution Funding Round 1 (ERF-R1); the ERF-

R1 contract is attached. Visalia/Kings, Tulare Counties CoC is currently in the process of going under contract with the City to utilize funds to hire two (2) FTE staff (one Housing Navigator and one Transportation Liaison) under Encampment Resolution Funding Round 2 (ERF-R2); the ERF-R2 letter of support is attached.

Through Coordinated Entry and under both the ERF-R1 and ERF-R2 we have prioritized 50 families into Homekeys and No Place Like Home affordable housing apartment complexes in Tulare County. Each program has onsite case management to provide wrap around services and progressive engagement to keep people permanently housed and prevent recidivism.

Additionally, Visalia/Kings, Tulare Counties CoC has written letters of support (both attached) for the City of Visalia and the City of Hanford/Kings Community Action Organization's ERF-R3 applications. If awarded funds, these projects will receive the same prioritization as the City of Tulare's ERF project.

Child Welfare Services department is working on a plan for coordinated entry. Due to the highly confidential nature of a family's involvement in the child welfare system, we have not yet participated in the Coordinated Entry System. Coordinated Entry requires the use of Homeless Management Information System, which we have been using since our program launched; however, our local CoC, the Visalia/Kings, Tulare Counties CoC, is currently enhancing its data privacy policies in partnership with our Health and Human

Services Agency, which CWS is part of. The updated policy was scheduled to go to the Visalia/Kings, Tulare Counties CoC Board for consideration and approval in December 2023. When this step is completed, we can continue our efforts toward the utilization of Coordinated Entry.

INTERAGENCY AGREEMENT Between Kings/Tulare Homeless Alliance And Kings County Human Services Agency

WHEREAS, the Kings/Tulare Homeless Alliance ("Alliance") is responsible for coordinating community efforts to end and prevent homelessness within Kings and Tulare Counties;

WHEREAS, the Alliance is responsible for ensuring that all United States Department of Housing and Urban Development ("HUD"), the California Interagency Council on Homelessness ("Cal ICH"), and State of California Housing and Community Development ("HCD") Homeless Housing, Assistance and Prevention ("HHAP") awardees within Kings and Tulare Counties adhere to Federal, State, and local policy and procedures as established by the Alliance;

WHEREAS, the Kings County Human Services Agency ("Partner Agency") applied for HCD Homeless Housing, Assistance and Prevention funding to provide housing and homeless services to individuals experiencing homelessness in Kings and Tulare Counties.

NOW, THEREFORE, IT IS AGREED that the Alliance is responsible for Continuum of Care planning for homeless programs in the bi-county region, and Partner Agency, has applied for funds to provide homeless program services within Kings or Tulare Counties; the above parties mutually agree to the following terms and conditions:

I. Background

Kings County Human Services Agency ("HSA")

The County of Kings is a political subdivision of the State of California, formed in 1893. As a "general law" county, the county government structure is determined by the State Constitution and State General Law. The Board of Supervisors is the governing body for Kings County and many special districts. The Human Services Agency is the County's social services department, providing assistance and services to indigent individuals and families.

This MOU between the Alliance and HSA delineates the roles and responsibilities regarding the utilization and administration of Homeless Housing, Assistance and Prevention ("HHAP") funding and related activities with the California Interagency Council on Homelessness ("Cal ICH") and State of California Housing and Community Development ("HCD").

II. Responsibilities

The Alliance shall:

- A. Oversee the Homeless Management Information System (HMIS)
- B. Oversee the bi-county Coordinated Entry System (CES)
- C. Make HHAP funds accessible to community partners via the release of a Request for Proposals ("RFP"), Request for Applications ("RFA"), or similar competitive awards process.
- D. Retain a Racial Equity Coordinator for a period of at least three years to assist in identifying best-practice approaches to addressing housing and system inequalities.
- E. Hold monthly Membership Meetings with community partners serving the unhoused.
- F. Provide trainings for all client facing staff on CES, Housing First, Equal Access Rule, and the Violence Against Women Act. Additional trainings on scheduled on a quarterly basis on topics such as racial and LGBTQIA equity, tenant rights and eviction prevention, cultural competency, etc.
- G. Coordinate the annual Point-in-Time Count.

HSA shall:

- A. Work closely with the Alliance in the development of applications for Homeless Housing, Assistance and Prevention ("HHAP") funds inclusive of aligning goals, objectives, expenditure plans, racial equity, and related outcome measures.
- B. Target the utilization of HHAP funds to existing housing efforts underway in the community as identified and prioritized in the County's Local Homelessness Action Plan.
- C. Utilize the Homeless Management Information System (HMIS) data tracking system for services provided by HSA's HHAP plan. Timeliness and quality of data entered in the HMIS will be monitored monthly and during the annual monitoring site visit.
- D. Administer a Vulnerability Index Service Priority Decision Assistance Tool (VI-SPDAT) for all homeless individuals and families served by HSA.
- E. Actively participate in Alliance activities to include but not limited to the following: Point-In-Time-Count and General Membership Meetings.
- F. Participate in the Kings County Homeless Collaborative and will regularly engage its membership regarding information and activities related to HHAP.

III. Mutual Responsibilities

- A. Agree they will establish mutually satisfactory methods for the exchange of such information as may be necessary in order that each party may perform its duties and functions under this agreement; and appropriate procedures to ensure all information is safeguarded for improper disclosure in accordance with applicable State and Federal laws and regulations.
- B. Collaborate on addressing racial equity goals as mutually developed during the Homeless Housing, Assistance and Prevention (HHAP) application process.
- C. Engage in technical assistance and training opportunities provided through Cal ICH, HCD, and similar state agencies.
- D. Develop a listing of standard recommended and required training including but not limited to Trauma Informed Care, Motivational Interviewing, Cost of Poverty Experience, and Mental Health First Aid.
 - a. Funding to cover costs associated with training such as registration, licensing, or other fees will be born independently by each agency or if possible, will be offered at no charge or in-kind as part of our mutual agreement.
- E. Collaborate on applications for future rounds of HHAP.
- F. Communicate:
 - a. Changes to an existing project or change in sub-population served that is significantly different than what the funds were originally approved for, including any budget amendments submitted directly to the funder
 - b. Increase/decrease of other funding to a project that could affect projected numbers of participants served, program staffing, performance, etc.
 - c. Delays in the start-up of a new project
 - d. Programs having difficulty in meeting projected numbers served or performance outcomes.
- G. Participate in and comply with the regionally coordinated homelessness action plan.

IV. Coordinated Entry System

A Coordinated Entry System (CES) is defined as a centralized or coordinated process designed to coordinate program participant intake, assessment, and provision of referrals. A CES covers the geographic area, is easily accessed by individuals and families seeking housing or services, is well advertised, and includes a comprehensive and standardized assessment tool.

The overarching goals of a Coordinated Assessment System is to simplify access to services by clients, track systems outcomes to inform and enhance decision making, improve overall system efficiency, and leverage community resource to achieve the most impact.

HSA agrees to participate in the Alliance's CES. This includes the utilization of the Vulnerability Index Service Prioritization Decision Assistance Tool (VI-SPDAT). A VI-SPDAT shall be administered for each client/household attempting to access housing services. Each client/household's VI-SPDAT shall be entered in the local Homeless Management Information System (HMIS) for scoring and placement on the Housing Priority List.

The bi-county Housing Navigator will manage the Housing Priority List within HMIS and assign households to available beds with the Continuum. Agencies are bound by his MOU to accept clients/households as assigned by the Housing Navigator, providing the client meets program guidelines (e.g. chronic homeless, disability condition, veteran, etc.).

V. Data Sharing

KTHA and HSA are required to utilize the Homeless Management Information System (HMIS) data tracking system for HUD required data elements, services and case management activities. HMIS is participation is also a requirement of California Assembly Bill (AB) 977. HMIS is the computerized data collection tool specifically designed to capture client-level information over time on:

- 1. The characteristics and services needed of men, women, and children experiencing homelessness
- 2. The services provided to these clients

The system will be used for a variety of reasons, including efficient data sharing between authorized Partner Agencies, which will in turn provide more effective and streamlined services to clients.

VI. Term

This MOU is effective from the date of execution through the completion of the HHAP Program in Kings County, or five years, whichever is longer, unless otherwise agreed to by both parties in writing.

VII. General Provisions

- A. No waiver of any of the provisions of the MOU documents shall be effective unless it is made in writing which refers to provisions so waived and which is executed by the Parties. No course of dealing and no delay or failure of a Party in exercising any right under any MOU document shall affect any other or future exercise of that right or any exercise of any other right. A Party shall not be precluded from exercising a right by its having partially exercised that right or its having previously abandoned or discontinued steps to enforce that right.
- B. Any alterations, variations, modifications, or waivers of provisions of the MOU, unless specifically allowed in the MOU, shall be valid only when they have been reduced to writing, duly signed and approved by the Authorized Representatives of both parties as an amendment to this MOU. No oral understanding or agreement not incorporated herein shall be binding on any of the Parties hereto.

- G. Coordinate the Tulare County Task Force on Homelessness and will regularly engage its membership regarding information and activities related to HHAP.

A Coordinated Entry System (CES) is defined as a centralized or coordinated process designed to coordinate program participant intake, assessment, and provision of referrals. A CES covers the geographic area, is easily accessed by individuals and families seeking housing or services, is well advertised, and includes a comprehensive and standardized assessment tool.

The overarching goals of a Coordinated Assessment System is to simplify access to services by clients, track systems outcomes to inform and enhance decision making, improve overall system efficiency, and leverage community resource to achieve the most impact.

HHSA agrees to participate in the Alliance's CES. This includes the utilization of the Vulnerability Index Service Prioritization Decision Assistance Tool (VI-SPDAT). A VI-SPDAT shall be administered for each client/household attempting to access housing services. Each client/household's VI-SPDAT shall be entered in the local Homeless Management Information System (HMIS) for scoring and placement on the Housing Priority List.

The bi-county Housing Navigator will manage the Housing Priority List within HMIS and assign households to available beds with the Continuum. Agencies are bound by his MOU to accept clients/households as assigned by the Housing Navigator, providing the client meets program guidelines (e.g. chronic homeless, disability condition, veteran, etc.).

V. Data Sharing

HHSA is required to utilize the Homeless Management Information System (HMIS) data tracking system for HUD required data elements, services and case management activities. HMIS participation is also a requirement of AB977. HMIS is the computerized data collection tool specifically designed to capture client-level information over time on:

- The characteristics and services needed of men, women, and children experiencing homelessness
- 2. The services provided to these clients

The system will be used for a variety of reasons, including efficient data sharing between authorized Partner Agencies, which will in turn provide more effective and streamlined services to clients.

VI. Term

This MOU is effective upon Board signature and shall continue until terminated by either party with (30) thirty days written notice

VII. General Provisions

- A. No waiver of any of the provisions of the MOU documents shall be effective unless it is made in writing which refers to provisions so waived and which is executed by the Parties. No course of dealing and no delay or failure of a Party in exercising any right under any MOU document shall affect any other or future exercise of that right or any exercise of any other right. A Party shall not be precluded from exercising a right by its having partially exercised that right or it's having previously abandoned or discontinued steps to enforce that right.
- B. Any alterations, variations, modifications, or waivers of provisions of the MOU, unless specifically allowed in the MOU, shall be valid only when they have been reduced to writing, duly signed and approved by the Authorized Representatives of both parties as an amendment to this MOU. No oral understanding or agreement not incorporated herein shall be binding on any of the Parties hereto.

VIII. Conclusion

- A. This MOU, consisting of five (5) pages, is the full and complete document describing services to be rendered by the Alliance and HHSA for the Homeless Housing, Assistance and Prevention funding.
- B. The signatures of the Parties affixed to this MOU affirm that they are duly authorized to commit and bind their respective entities to the terms and conditions set forth in this document.
