## 1. Homelessness Response System Gaps Assessment

---

When determining local funding priorities, it is critical to understand the current gaps in the local homelessness response system. Each community faces unique challenges in reducing and ending homelessness, so an assessment of current resources and understanding the needs yet to be fulfilled is critical to ensuring the effective and efficient use of new resources. This can be done in various ways and can include conducting a community needs assessment, holding local public forums, talking with service providers and people experiencing homelessness, and utilizing [HUD's seven system-level performance measures](#) that help communities gauge their progress in preventing and ending homelessness.

To successfully complete this section of the application, applicants will need to provide the following:

Homelessness Response System Gaps Question 1a - Begin Answer  
The Continuum of Care (EDOK) examined the most recent HUD Point-In-Time (PIT) count data, the HUD Housing Inventory Count (HIC) data, data compiled from the Homeless Management Information System, and data derived from the local "2-1-1" system. While no formal gaps/needs assessment has been conducted from which all of the data measures have been examined in aggregate, the local gaps/needs within the system are stark and obvious, both seen in data as well as anecdotally.  
The 2019 PIT Count data indicates 78% of the County's homeless population is unsheltered (N=480), with 22% currently sheltered. The 2020 PIT data showed a total of 183 persons experiencing sheltered homelessness, which included 145 people in emergency shelters and 38 people in transitional housing. However, contrasting with the 2019 PIT County, the local HMIS system holds VI-SPDAT data dating back to 2017, with 1271 unique individuals identified.  
The HIC data from January of 2020 shows a total count of 270 units in inventory (330 total when factoring/including emergency

housing, transitional housing, rapid rehousing, and permanent supportive housing). HNR- El Dorado County 2019 report data indicates El Dorado County has a shortfall of 3,070 affordable rental homes, and that of the Extremely Low Income populations of El Dorado county, 77% were Severely Cost Burdened, spending more than 50% of their monthly income towards housing costs. For the County's Very Low Income citizens, 69% were either Cost Burdened or Extremely Cost Burdened, and of Low Income households, 65% were Cost Burdened or Extremely Cost Burdened. Obviously, there is insufficient inventory to meet demand throughout the system. The last HIC Count was conducted in January 2020 before the beginning of the COVID19 pandemic. Taxonomy data derived from the local "2-1-1" referral system shows 43% of callers are seeking assistance with basic needs - housing assistance, utility assistance, and nutrition assistance being the largest subsets in that category.

Persons with lived experience of homelessness have a role/position within the CoC Board, which met to discuss system gaps and needs prior to providing direction to the Administrative Entity for the HHAP Round 2 Application. Additionally, both the PIT Count and taxonomy data derived from the "2-1-1" referral system capture needs data directly from those with lived experience of homelessness. As prioritizing eligible uses for this application is being grounded specifically in the data available, the CoC is using the input received from those with lived experience of homeless to specifically address gaps identified by this population.

EDOK currently does not have any member organizations that have historically served communities of color. Currently, there is no

information available to indicate any such organizations exist within El Dorado County. EDOK has taken steps to ensure any organization receiving funding from the ESG-CV Request for Proposals examines racial disparity data as a part of their service provision; it also requires organizations create and implement plans for addressing racial disparity data. However, until organizations that serve communities of color can be identified within the County, EDOK will struggle to invite these organizations to have more active participation.

Homelessness Response System Gaps Question 1d - Begin Answer

Gaps have been assessed across the system to prioritize services that do not currently exist or that do exist at a level that is insufficient to address basic needs. As a result, current assessments do not specialize victim populations in particular, other than using VI-SPDAT data to identify risk factors, which may or may not include those chronically homeless, those with a disability, as well as individuals with children/families.

Homelessness Response System Gaps Question 1e - Begin Answer

The County has examined the COC Outcomes by Race and Ethnicity data (compiling PIT Count data and information provided through the American Community Survey Data). In response to the Emergency Solutions Grant Coronavirus (ESG-CV) Program, the County is requiring future homeless service providers to submit plans for addressing racial disparities as a requirement in seeking funding, regardless of the eligible activity area.

formal gap assessment has not been conducted. The data aggregated to address gaps within the current system are pulled

from multiple data points collected at unique intervals. Formal PIT Counts are conducted biannually, consistent with HUD requirements. Annual HIC and PIT surveys of sheltered homeless individuals are conducted annually. "2-1-1" Taxonomy data is collected at the time of call and reporting can be extracted on demand. Additionally, the HMIS system houses VI-SPDAT data beginning from 2017 (to present).

Needs/gaps analysis data resulting from multiple data points, along with input from the community, is an important factor in guiding the decision making process for the CoC as well as the County. Because the County has a multitude of needs across many different service areas, the available data is used to help triage efforts to ensure the limited funding available can have the greatest impact.

Performance evaluation for the homeless system exists as a function of the subaward management process. Subrecipients selected for funding from HHAP-2 (or other fund sources) are required to submit progress reports identifying efforts and outcomes data. Programs that demonstrate positive outcomes are considered for future funding opportunities that may continue the successful project, whereas projects that do not demonstrate successful outcomes are usually left to expire. In either scenario, when expenditures are not consistent with projections, the funds may require re-allocation to ensure funding is expended prudently and consistent with the funding timeline.

Homelessness Response System Gaps Question 2a - Begin Answer

VI-SPDAT data indicates 1271 persons have been identified and assessed within the local homeless system since 2017. The 2019 PIT Count showed a total of 613 persons who were homeless, a significant difference from those individuals identified prior to and since the county began counting individuals using the VI-SPDAT. Demographically, the PIT Count data indicates 26% of the count was from individuals aged 24 or younger; sixty-three percent (63%) were male. Racially, the population was not too dissimilar from census data for the County: eighty-five percent (85%) identified as white, five percent (5%) identified as African-American, and four percent (4%) identified as Native American. Of the 613 counted, nineteen percent (19%) reported to be chronically homeless while forty-seven (47%) reported having lived their entire life before experiencing homelessness in El Dorado County.

The County and CoC's homeless efforts are currently funded through the California Emergency Solutions and Housing Program (CESH), the Homeless Emergency Aid Program (HEAP), the Homeless Housing Assistance Program (HHAP), the No Place Like Home Program (NPLH), as well as several grant funds contributing specifically to support the COVID-19 response including but not limited to the County Medical Services Program (CMSP) COVID-19 Emergency Response Grant Program, COVID-19 Emergency Homeless Funding administered by the Homeless Coordinating and Financing Council, the CARES Act, and the Emergency Solutions Grant - Coronavirus (ESG-CV) grants.

We do not currently have data that specifically identifies gaps or disparities in access or delivery of services, housing placement, and/or housing retention outcomes for these populations.

## Homelessness Response System Gaps Question 2c - Begin Answer

We do not currently have data that clearly demonstrates racial or ethnic disparities in access to services, delivery of services, housing placement, and housing retention outcomes for homeless with any reliability/data integrity. We have data that shows some racial disparities, but because the actual count size is so small, it is difficult to identify whether these disparities are nominal/statistical or actual. As a result of future solicitations for projects we are intent on gaining data from service providers on racial disparities that exist within service provision and a plan for mitigating these disparities.

We do not have data that establishes any other known disparities in the delivery of homeless services including rates of successful permanent housing placements and/or housing retention rates.

## Homelessness Response System Gaps Question 2d - End Answer

- e. Using the Service Gap Analysis Chart below, identify which areas of the local homelessness response system (e.g. shelter, rental subsidies, supportive housing) have gaps in resources based on the needs of people experiencing homelessness in the community.

## Homelessness Response System Gaps Question 2e - Begin Answer

PIT Count data shows 480 unsheltered homeless individuals, while the HIC Survey indicates 174 individuals are currently placed in emergency shelter. HIC data also indicates 85 individuals are currently receiving Rapid Rehousing Assistance, which would include rental assistance/subsidies, in addition to 5 veterans receiving permanent supportive housing assistance.

According to population-level (census) data, "Black or African American Alone" makes up 1% of the population. According to our 2019 comprehensive PIT Count, this demographic comprised 5% of the homeless population in the community, representing a 500% greater representation among homeless individuals. Conversely,



however, according to our 2020 HIC-sheltered PIT Count, this same demographic represented 8.7% of the sheltered homeless population in El Dorado County programs. An increase in the representation of the sheltered population represents a step forward in analyzing and addressing gaps in services.

## 2. Regional Resources Planning

---

When working within the homelessness system, it is critical to assess the current resources available within the community to ensure any new resources are most effectively and efficiently targeted to best serve people experiencing homelessness within the community. Given the high number of people experiencing homelessness in California and the unprecedented amount of federal and state funds available to address homelessness, HCFC expects applicants to coordinate all available funding to safely shelter and permanently house as many people experiencing homelessness in the applicant's community as possible, with a particular focus on rehousing individuals currently living in Project Roomkey (PRK) sites.

Regional Resources Planning Question 1 - Begin Answer

The County, working as the Administrative Entity for the CoC, works closely with the CoC to ensure local, state, and federal funding allocations awarded to the CoC and administered by the County work in coordination with those awards made directly to the County. In support of the effort, the County has created a map of all funding, differentiating allocations for both the County and CoC, that clearly shows the eligible activity areas being supported across all funding streams. This effort is furthered by an administrative team that assists the CoC in developing applications/proposals for funding in coordination with the CoC to ensure

considerations across the community are addressed while a plan for funding is in development.

### 3. HHAP-2 Funding Plans

---

When planning how to target new HHAP-2 resources, it is essential to do so in direct response to the gaps assessment and current regional investment planning described in Sections 1 and 2. HHAP-2 funding plans must state the specific gaps that will be addressed with these new funds and provide sufficient detail to ensure that any selected projects will effectively meet identified gaps. HCFC expects applicants to clearly understand and identify the intervention types requiring funding prior to initiating their local project selection processes.

Intervention Types are broken into six categories: (1) Outreach; (2) Interim Housing; (3) Rental Assistance; (4) Permanent Supportive and Service-Enriched Housing; (5) Diversion and Homelessness Prevention, and (6) Services.

#### HHAP-2 Funding Plans Question 2 - Begin Answer

The CoC and County are dedicating \$510,350 towards Rapid Rehousing efforts with the primary target of these efforts being individuals currently housed as a part of Project Roomkey. The funding made available for the Rapid Rehousing effort is provided by the ESG-CV Round 1 and Round 2. Based on the total number of individuals currently housed in NCS, the County anticipates a cost per client that exceed \$10,000, a cost benchmark used for Rapid Rehousing clients eligible for CalWorks as a part of the Housing Support Program (HSP). As extra insurance that RRH can be performed expediently while a service provider is selected through a formal solicitation for ESG-CV, the CoC has also expressed a desire in allocating an additional \$275,000 (approximately) of HHAP Round 1 funding, subject to a budget adjustment approval by BCSH. With sufficient funding currently dedicated to pay for PRK costs and a generous sum dedicated to Rapid Rehousing PRK clients, the CoC and County have decided to focus HHAP Round 2 funding to meeting long-term emergency/short-term housing goals that cannot yet be implemented but will become vital in the near future.

#### HHAP-2 Funding Plans Question 3 - Begin Answer

With an extremely limited cap on administrative costs, HHAP Round 2 does not present sufficient opportunity to budget adequate staff time to grant administration without directly studying the grant administration activities to HHAP Round 2. While this could be accomplished, the grant administrative activities are broken up between accounting/accounts payable activities, contracting activities, etc. in addition to program metrics/reporting. Each of these roles represents a statistically small amount of time commitments across multiple units. Time studying these traditional indirect costs in order to direct-cost small fractions of an FTE to this one particular fund stream would likely be considered impractical and imprudent. This effectively forces the County to leverage indirect costs it will not be sufficiently reimbursed for to help perform the grant administration required for the funding. Additionally, even if it were prudent for the County to time study grant administration/management activities for HHAP Round 2, as the Administrative Entity for the CoC, the County would be forced to rely on a CoC allocation of funding to support a paid County position, a maneuver that would pose financial risk to the

County should the CoC decide to reallocate funding dedicated for this position to another community partner.

The County has an existing Senior Department Analyst and Housing and Homeless Program Manager. The Analyst is funded through indirect costs, and the newly recruited Housing and Homeless Program Manager is funded through other, permanent funding sources. Both of these positions will be actively involved in the grant management activities for HHAP 2 within insufficient administrative costs allowed in funding to dedicate additional resources.

Both the County and the CoC intend to set aside the required 8% of funding in support of homeless youth. Solicitations for service providers who specifically serve youth are performed independently to ensure the selected vendors have sufficient expertise to serve youth in particular. Otherwise, clients served in both systems must enter through Coordinated Entry Services, and from point of entry are referred to the appropriate service providers/resources to meet their needs.

## 4. HHAP-2 Goals

---

Creating performance targets that can be clearly measured every year ensures a commitment to locally shared goals. #### HHAP-2 Goal Question 1 - Begin Answer

Systemwide, El Dorado County's primary goal is to reduce the number of unsheltered homeless individuals through permanent housing placements. Secondly, the CoC and County are both fully committed to a system where 100% of homeless service providers are using HMIS, 100% of homeless services are Housing First, and 100% of clients served are assessed, entering the system by way of coordinated entry. These goals may seem small and are perhaps the standard in many places. However, El Dorado County is new to homeless services. Many providers do not have a long or storied history of serving homeless clients; many are still building basic organizational/functional capacity. Over the last several years, these organizations have started at a grass roots level, and the CoC and County have been thankful for the contributions. However, the grassroots nature of these developments has resulted in some inconsistency in data inputs and management, as well as standardization in assessments and entry points. Philosophically, Housing First is a relatively new concept in a rural county, and it has taken a vast investment of energy and discussion into trying to win over doubters of the concept.

#### HHAP-2 Goals Question 1 - End Answer

#### HHAP-2 Goal Question 1 - Begin Answer

HHAP Round 1 was only awarded in April of 2020. The pandemic had just arrived in earnest, while the proposed goals/plans for the funding had been developed prior to the pandemic. At present, the County has approximately 40 individuals currently housed in Non-congregate Shelter (NCS) sites that need rapid rehousing and assistance locating permanent housing. The County and CoC are committed to rehousing as many as possible as quickly as possible before money for NCS is exhausted. That being said, there are realities to the situation. The solicitation process launched for ESG-CV funding (an RFP) takes months to accomplish and months more to get a contract in place. Meanwhile, the County and CoC are together expending in excess of \$108,000 per month on NCS efforts. As a result, rehousing as many clients at NCS sites is fiscally the only reasonable path forward, yet the funding available for rehousing efforts

has to move through administrative barriers in order to being taking effect. As a result, in order to expedite the rehousing effort, the CoC is intent on seeking a budget adjustment from HCD to reallocate funding to support Rapid Rehousing as quickly as possible. The adjusted goal for HHAP Round 1 would be to rehouse approximately 25% of those currently housed in NCS sites (N=10).

## 6. Racial Equity Efforts

## 7. Regional Collaboration and Partnerships

---

HHAP program funds are intended to support regional coordination and expand local capacity to address homelessness. Demonstration of how jurisdictions have coordinated and will continue to coordinate with other jurisdictions is a critical factor of funding. With HHAP-1 funding, applicants were required to partner with other applicants to make collective funding decisions for their communities. HHAP-2 funding should increase and improve those partnership efforts.

Regional Collaboration and Partnerships Question 1 - Begin Answer

Our region includes two HHAP allocations, one for the CoC and one for the County. Both the CoC and County have had numerous meetings discussing not only the funding allocated through Round 1 but also the pending allocations of Round 2 to ensure funding was prioritized to meet the communities need and strategic priorities rather than the intent of any particular organization. Discussions for both allocations for both rounds have been had at CoC general membership meetings as well as CoC Board meetings and separate discussions with the CoC funding committee. As a newly agreed upon tenant of HHAP Round 2 funding, both the County and CoC have committed to dedicating the allowed 5% portion of Round 2 funding to support building a more inclusive, collaborative environment for HMIS. A previously identified barrier to HMIS use was the cost of user licenses and training on the system. Both the CoC and County are allocating funding specifically to HMIS to help overcome these barriers and build a more coordinated, collaborative, data-sharing system for all partners serving the community.

The County and the CoC work hand in hand together both in identifying new funding priorities and reallocating/changing previously determined priorities as needs evolve/change. Because the County serves as the Administrative Entity for CoC funding in addition to administering its own funding, the

County has taken steps to ensure a common operating picture on the various funding streams that are active, the uses of these funds, and the status of expenditures. As the plans for the funding were developed collaboratively and complementarily, when changes are required, the County engages the CoC members to discuss the changes, seeking input when necessary to reallocate unexpended funding.

HHAP Round 1 planning coordinated goals/strategies/objectives that were in large approximations based on a strategic plan in development. As a result, planning for Round 1 was a relatively new phenomena that lacked many detailed specifics of how the partnership would evolve moving forward. Subsequent to the award of Round 1, dealing with some of the details of roles/responsibilities, defining process, etc. came much more to the forefront, as what had been agreed upon in concept had to be actualized administratively. Because the CoC is comprised of many different contributors from many different organizations the simple act of getting the right people in the room to have on-going, detailed conversations has been a challenge. However, as a result of the cultural shift to web-based meetings, anecdotal evidence suggests overcoming the meeting/scheduling barriers has been greatly reduced/simplified.

HHAP Round 2 funding will provide continued support for some of the strategic goals/priorities identified in Round 1 in addition to providing a strong footing for continued HMIS use/training moving forward. To that end, it will certainly support building a better, more collaborative, more robust HMIS system throughout the County. It is uncertain whether existing partnerships will "scale" as a result of Round 2 funding; it is clear that Round 2 represents another funding stream supporting the on-going effort that will require additional dialogue, meetings, and decision making in order to successfully navigate.

However, when the COVID19 pandemic began, the limited local resources appropriated to address homelessness were required to reprioritize. Homeless service providers across the service area needed to prioritize triage efforts, most notably to organize and implement non-congregate shelter sites.

As a result of HHAP Round 1 funding, the County administered an informal selection process for homeless youth prevention and shelter diversion projects. This process was used to select eligible, qualified projects for each of the allocation's youth set aside funding. As a result of the informal process, two proposals were received: one from Whole Person Learning and a second from Tahoe Youth and Family Services. Both organizations were selected to provide services to homeless youth as a result of HEAP funding, which is set to expire in June of 2021. With HHAP funding now being allocated to these projects, the projects will be able to continue past June of 2021. Both projects serve homeless youth in the South Lake Tahoe region of El Dorado County.

Homeless prevention and diversion funding from the HHAP 2 opportunity will extend the project life of current homeless prevention and diversion activities for Transitional Aged Youth in the South Lake Tahoe Basin.

These funds would provide time-limited rent assistance, which coupled with case management services provides stabilization to transition aged youth.

Eligibility for this program specifically utilizes the criteria for Category 2- Imminent Risk of Homelessness. Without access to these services, eligible youth are at imminent risk of losing their housing within fourteen (14) days and do not have the ability to find other housing in a timely enough manner to prevent homelessness or entry to an emergency shelter.

While the Emergency Rental Assistance Program (ERAP) will serve a critical role in addressing the economic hardship and housing insecurity relating to the COVID-19 pandemic, these funds are set to expire in Summer 2021. The HHAP Round 2 funds would not be utilized until all federal and state Prevention and Diversion funds through ERAP and potential future programs have been exhausted.

Navigation Center program staff will ensure the client has the support s/he needs to meet goals by assisting the client in defining sequentially appropriate steps towards goal attainment. Case managers and/or program staff define target dates for attainment to help clients achieve defined goals in a timely and efficient way. Program staff will actively intervene and resolve/escalate where barriers to services exist, though the need for intervention will vary by client.
