To successfully complete this section of the application, applicants will need to provide the following:

Homelessness Response System Gaps Question 1a - Begin Answer The County of Lake, on its own and through its Continuum of Care (CoC), utilizes all available, reliable data for a variety of local and other resources. Locally, the CoC's HUD Point-in-Time homeless count, conducted annually, provides some basic information of homeless as narrowly defined for that purpose. More broadly but still utilizing HUD-accepted homelessness definitions (McKinney-Vento Act, for example) the county reviews data collected by local service providers, the US Census with CA annual demographics updates, and others such as the national Robert Wood Johnson Foundation. Input from homeless and at-risk individuals or their representatives provide additional information helpful in pinpointing service gaps. Additionally, the CoC has just initiated its new HMIS for all funded service providers. One major effort is its annual Mental Health Services Act (MHSA) Five-Year Plan and its annual review with update.

Homelessness Response System Gaps Question 1a - End Answer

b. How people with lived experience of homelessness had ongoing meaningful and purposeful opportunities to participate in and inform the most recent gaps assessment and how they have meaningful opportunities to inform all levels of system planning over time;

Homelessness Response System Gaps Question 1b - Begin Answer The county's Behavioral Health Services dept. serves as administrator for the CoC. CoC membership includes formerly homeless individuals. The HUD PIT outreach workers and regular service providers also request input from the homeless on what services are needed and which ones being provided are most effective. The CoC as well is currently working on its first HUDrequired Strategic Plan which will address how to include input from all impacted groups, including the homeless. Additionally, Behavioral Health Services actively seeks to include homeless and formerly homeless in its Mental Health Services Act (MHSA) Plan and regular updates, particularly when addressing emergency and permanent supportive housing needs.

Homelessness Response System Gaps Question 1b - End Answer

c. How organizations that have historically served communities of color but may not have previously participated formally in the CoC and may not be a part of the homelessness provider community had meaningful and purposeful opportunities to participate in and inform the most recent gaps assessment and how they will be engaged in system planning over time;

Homelessness Response System Gaps Question 1c - Begin Answer Under the direction of the county's Behavioral Health Services department, the CoC is working hard to encourage representative groups not historically served to participate more fully in the CoC's regular meetings. However, the Strategic Plan will address how to obtain meaningful input from all traditionally underserved communities so that service gaps are identified and addressed as future projects are planned and funded.

Homelessness Response System Gaps Question 1c - End Answer

d. How gaps were assessed for special populations such as families, youth, victims of domestic violence, seniors, persons who have been convicted of a crime, persons with a disability, persons who are chronically homeless, persons with HIV/AIDS, persons who are LGBTQ, veterans, persons with limited English proficiency, and persons who are undocumented;

Homelessness Response System Gaps Question 1d - Begin Answer Under the county's direction, the CoC is specifically recruiting active members who are, or who serve, all special populations. Lake County particularly as an agricultural community has a significant number of undocumented individuals, some of whom speak only indigenous languages from Mexico and Central America. Too, Native Americans represent a large number of the at-risk population but who have historically participated little with the CoC. Therefore the CoC's Strategic Plan is specifically addressing how to reach all special populations, although much already has been done in this area since the Lake County CoC was reorganized two years ago under the direction of the Lake County Behavioral Health Services department. It already has initiated a monthly meeting of service providers, including representatives of tribal, veterans, Latinos and local law enforcement to discuss these issues.

e. How racial or ethnic disparities in the delivery of homeless services were assessed;

Homelessness Response System Gaps Question 1e - Begin Answer The County and the CoC use both local data and the experience of local service providers when monitoring the delivery of services to the county's racial and ethnic minorities. The CoC recognizes it needs to conduct more thorough outreach and it is addressing this in its Strategic Plan now underway. The county's MHSA planning process additionally works hard to include representation from all disparate communities.

Homelessness Response System Gaps Question 1e - End Answer

f. How frequently gaps assessments are conducted;

Homelessness Response System Gaps Question 1f - Begin Answer The CoC annually conducts its HUD Point-in-Time homeless count annually. It uses count data to compare services demand with field findings. Service providers further consider gaps when preparing regularly required reports for the different funding sources. The county, as part of its MHSA process, annually reviews the plan's progress and adjusts when gaps are identified.
[In late January 2021, the CoC was one of a handful of entities conducting a Covid Point-in-Time count. This count identified 241 persons meeting the HUD PIT criteria. This included 216 males, 100 females, 1 transgender male, 1 transgender female, and 1 self-identifying as nonconforming. Five were under the age of 18, with another 12 persons between ages 18 and 24. Fifty-nine persons were classifies as elderly, and 16 were US veterans. Over 21% were

Latino (which is comparable to the county's demographics) but almost 4% were Black (2x county makeup). A shocking 23% identified as Native American, far exceeding the county's reported demographics.

But the HUD PIT count excludes many homeless or at-risk individuals otherwise eligible for HUD McKinney-Vento and other state funding. For example, the county's 2019 No Place Like Home plan reported that approximately 10% of Lake County students, or about 960 (not including their families!) were identified by the Lake County Office of Education as homeless for at least part of thee 2018-2019 school year. The Plan also estimated that about one-third of homeless veterans are chronically homeless.]

Homelessness Response System Gaps Question 1g - Begin Answer The MHSA planning and update process seeks to identify new needs and current gaps in services, including in the housing of its special needs populations. Those findings direct future funding directions. The CoC's HUD PIT count helped to determine locally the need to establish year-round emergency shelter/navigation centers. Two such centers were opened last year, largely because of the initially awarded HHAP funding. [The Strategic Plan underway will utilize all legitimate sources of homelessness and those at-risk to better quantify local needs and provide a process to strategically prioritize those needs and target services to make the most of limited resources.]

Homelessness Response System Gaps Question 1g - End Answer

h. How the applicant will conduct ongoing system performance evaluation to ensure the impact of HHAP-2 funds throughout the spending period and determine if adjustments are needed to address gaps in the homelessness response system.

Homelessness Response System Gaps Question 1h - Begin Answer The Lake County CoC just this month voted at its regular meeting to amend its by-laws with the establishment of a funding award and performance review committee. This permanent, standing committee includes CoC members and administrative staff, charged with the recommendation to the full membership on funding awards, based on community needs, identified gaps, and previous performance of providers. This committee further will review all regular performance, including expenditure, reports so it

can monitor programs' efficacy and recommend program expansions and additions to better meet prioritized needs.

Homelessness Response System Gaps Question 2a - Begin Answer The Lake County CoC is currently completing its first LSA for HUD which identifies the number of homeless with its demographics. However, the HUD reporting system (STELLA) is currently down. We have been assured by HUD the problem will be fixed shortly. Meanwhile, BCSH, the state HHAP funding entity, has requested we place an email it sent us within this application in acknowledgement of this HUD problem. We will provide the requested information as soon as we are able to enter the system and complete the report. [According to HUD's 2020 Annual Homeless Assessment Report to Congress, Lake County had the highest percentage of unhoused homeless in the U.S.: over 94 percent. The CoC's 2020 PIT count identified 572 unhoused individuals ranging in age from 5 months to 94 years. Approximately 40 percent were women. About 6 percent were under 18, and nearly half were between 22 and 44 years of age. The average length of Lake County residency was almost 18 years, with about half attributing their homelessness to the recent wildfires. About 10 percent were Latino. Seventy-seven individuals self-identified as US veterans. No Native Americans or LGBTQ individuals self-identified as homeless.1

# 2. Regional Resources Planning

membership includes representatives from its two incorporated cities plus
the county, and the county serves as its administrative entity. An elected
member of the county's Board of Supervisors also currently serves as the
CoC's vice-chair and regularly updates the entire Board at its regular
publicly-open meetings of CoC activities.

#### 3. HHAP-2 Funding Plans

When planning how to target new HHAP-2 resources, it is essential to do so in direct response to the gaps assessment and current regional investment planning described in Sections 1 and 2. HHAP-2 Funding Plans Question 2 - Begin Answer

This application requests HHAP-2 funding for the conti

This application requests HHAP-2 funding for the continuation of emergency shelter operations initiated, in part, with the original HHAP funds. Lake County, both directly and through its CoC, has an active Project Roomkey underway and it will continue to support it utilizing other recent homelessness intervention and prevention funding sources such as ESG and CESH. Additionally, the county's housing consultant preparing this grant application recently was "lent" to a local Native American tribe seeking Project Homekey funds to provide permeant, affordable housing form homeless and at-risk tribal members. That grant application was successful and was immediately used to purchase and rehabilitate a tenunit apartment building now housing several individuals to large families. HHAP-2 Funding Plans Question 2 - End Answer

3. Describe the activities budgeted for grant administration. In the applicant's response, describe the overall grant administration staffing plan to accomplish the applicant's goals and activities. HHAP-2 Funding Plans Question 3 - Begin Answer

This application requests the allowed 7 percent funding for general administration. County oversight of its emergency shelter, managed by a contracted service provider, requires significant staff time. Funds disbursement, with required review of provider requests then processing through the county's fiscal oversight and disbursement system, is complicated. Too, Behavioral Health services staff spend significant time in tracking data and preparing the regular HCFC reports required with HHAP funding awards.

HHAP-2 Funding Plans Question 3a - Begin Answer

Lake County Behavioral Health Services last year hired a FT grant management person. She spreads her time over various grant programs and we anticipate about 5 percent of her position will be used on HHAP administration. But in addition, the department's MHSA and Housing Program Manager oversees all related programs and additionally serves

as staff and advisor to the CoC; at least 20 percent of his time is dedicated towards these housing grants involving homelessness.

b. Existing staff positions that will be leveraged to fulfill this need.

 Program Manager. Additionally, the department's director regularly reviews all program performance and regularly participates in emergency shelter discussions/issues and CoC meetings. The 5-person county Board of Supervisors also is regularly updated on the emergency shelter, particularly since is involves COVID and county performance under state directives.

HHAP-2 Funding Plans Question 3b - End Answer

In what ways the applicant's jurisdiction is leveraging the adult system to serve youth and in what ways the homelessness response system has been or will be adapted to youth; and how the applicant will use HHAP-2 funding to ensure youth can access services and that targeted spending meets their needs.

HHAP-2 Funding Plans Question 4 - Begin Answer

The county's emergency shelter has adapted its facility to safely include youth as needed. It's contracted service provider is experienced in the delivery of youth services, Housed youth further are consulted as to whether their needs are being met and if adjustments can improve their experience. Behavioral Health Services also operates other youth-oriented programs and those services with staff are engaged as needed.

[Additionally, Lake County agrees to participate in available TA from the state to increase awareness and service that speak to the specific needs of the youth that are experiencing homelessness in the community.]

HHAP-2 Funding Plans Question 4 - End Answer

The county's two emergency shelters regularly request input from and involvement of their clients in an effort to further improve their own experiences and those of future residents. Regular performance reports to the CoC are provided. Further, the CoC's inclusion of formerly homeless in its own strategic planning efforts and HUD PIT counts additionally ensures legitimate programs design and effective implementation that maximizes client satisfaction and future success with permanent housing.

HHAP-2 Goal Question 1 - Begin Answer

Lake County has been negatively and severely impacted the past several years by a series of wildfires and one major Clear Lake flooding event. These disasters collectively resulted in a significant increase in local homelessness. The county takes particularly care in tracking services for those who self-identify as previously losing their housing directly or indirectly because of the recent disasters.

HHAP-2 Goals Question 1 - End Answer

2. An update on systemwide goals identified in HHAP-1 and explanation of any goal modifications made in response to changing needs.

HHAP-2 Goal Question 1 - Begin Answer

The HHAP-2 Goals-Programmatic section will be completed once the HUD HDX LSA can be completed and submitted. The county's goal for HHAP round one funds was the establishment of an emergency shelter. No additional systemwide goals have been identified; the actual establishment of the county's first year-round emergency shelters (for others than domestic violence victims) utilizing the first round of HHAP funds was a HUGE accomplishment and therefore their continuing operation remains the top goal.

HHAP-2 Goals Question 1 - End Answer

3. At least one clear, measurable performance goal related to how HHAP-2 funding will address racial disparities identified in the jurisdiction's homelessness response system.

HHAP-2 Goal Question 1 - Begin Answer

The county continues to regularly monitor its operations for racial disparities. It is, however, determined to improve its relationship with the providers of services to Latinos (including seasonal farmworkers) and Native Americans to ensure those communities will receive their needed share of all homelessness assistance funding received by the county. [GOAL #!: Regularly monitor programs' performance on racial equity and outreach; adjust as necessary so that services are provided are commensurate with local need and demand.

GOAL #2: Recruit and maintain regular participation with and cooperation among county organizations ]representing all traditionally underserved groups, particularly Latinos, Native Americans and Blacks. GOAL #3: Require all housing service providers to provide bilingual (English/Spanish) access.]

Our data shows racial disparities in the number of individuals experiencing homelessness who identify as Latino or Native American compared to the overall county population. By January 31, 2022, Lake County & Lake County CoC: 1) work closely with HCFC to clearly define the disparities and identify the specific interventions needed to reduce these disparities and 2) establish new measurable, outcomes-focused numeric goals to reduce the identified disparities and will provide those to HCFC by this date.

HHAP-2 Goals Question 1 - End Answer

In particular, however, the county has been more intensively discussing how to meet the particular needs of the LGBTQ population, which it believes is disproportionate among homeless youth. Youth aging out of the foster care system also are at risk of homelessness and another particular concern. The county's Behavioral Health Services department has specialized staff and services in this area and is actively working in these areas.

About 6% of our population speak no or little English. A large majority of the native Americans are enrolled members of one of the 7 federally recognized tribes in Lake County. We acknowledge that we must ensure services are equitably delivered, and the Strategic Plan under development will concentrate its efforts on doing this through specific policies and procedures.]
