## **NOTICE OF CONDITIONAL AWARD**

TRIBAL HOMELESS HOUSING ASSISTANCE AND PREVENTION PROGRAM (Tribal HHAP), ROUND THREE

As authorized by Assembly Bill (AB) 140 and AB 129, and in consideration of the response to the Tribal Homeless Housing, Assistance and Prevention Program (Tribal HHAP) Round 3 Notice of Funding Availability (NOFA), the California Department of Housing and Community Development (HCD) has conditionally awarded \$20 million in Tribal HHAP Round 3 funds across 37 California Federally Recognized Tribes.

Pursuant to HSC Section 50234(a)(4)(A), tribes may apply for Tribal HHAP Round 3 funds and shall be allocated funds up to their requested amount, or up to a total of \$20 million collectively among all tribal applicants. If the total request for funds exceeds the total available, HCD shall determine an allocation methodology based on each tribal applicant's proportionate share of need relative to all tribes that submit an application. HCD received requests for over \$120 million in funding across 37 applications and the following allocations were determined per that methodology to collectively provide \$20 million across all Tribal HHAP Round 3 applicants. HCD will work with all 37 applicants to submit revised budgets within the allocated amounts and move to finalize awards and disburse funds.
