2023 Homekey TribalAward Announcement

The California Department of Housing and Community Development (Department) is pleased to announce the award of \$70,963,680, awarded to ten Homekey Tribal (HKT) Applicants:

- Big Sandy Rancheria of Western Mono Indians of California, Big Sandy Rancheria Homekey Project, is in a Rural Area of Fresno County and awarded a total of \$4,485,587. The award will fund 12 permanent, rental housing units for Homeless and At-Risk of Homelessness populations.
- Yurok Indian Housing Authority, Klamath Glen Yurok Homes is in a Rural Area of Del Norte County and awarded total of \$4,741,116. The award will fund 24 permanent, rental housing units for Homeless and At-Risk of Homelessness populations.
- Dry Creek Rancheria, Bi'du Khaale, is in a Rural Area of Sonoma County and awarded a total of \$12,000,000. The award will fund 25 permanent rental housing units for seniors, 55 and over, and their families.
- Colusa Indian Community Council, CICCs Old Res Housing Complex, is in a Rural Area of Colusa County and awarded a total of \$8,336,672. The award will fund 21 permanent, rental housing units for Homeless and At-Risk of Homelessness populations.
- Round Valley Indian Housing Authority, Tribal Winds Phase 5, is in a Rural Area of Mendocino County and awarded a total of \$8,776,001. The award will fund 18 permanent, supportive rental housing units for Homeless populations.
- Two Feathers Wellness Village is in a Rural Area of Humboldt County and is awarded a total of \$4,131,114. The award will fund 8 permanent, supportive housing rental units for households experiencing Homelessness.



- Kuh-la-Napo, is in a Rural Area of Lake County and is awarded a total of \$6,556,818. The award will fund 20 permanent, supportive housing rental Units. All Units will serve Homeless and At-Risk of Homelessness populations.
- Maidu Mountain Lion Housing Project is in a Rural Area of Butte County and is awarded a total of \$6,897,713. The award will fund 12 permanent, supportive housing, single family rental housing Units. All Units will serve households at Risk of Homelessness.
- Scotts Valley Senior Community is in a Rural Area of Lake County and is awarded a total of \$3,038,659. The award will fund 8, permanent affordable housing units for Seniors.
- FTBMI San Fernando is in Los Angeles County on Fee Land and is awarded a total of \$12,000,000. The award will fund 26 permanent, affordable housing units for Seniors.
- To date, HKT funds have awarded a total of \$70,963,680 to ten HKT projects, that will result in 172, permanent, affordable housing units for the target populations.
