Con Plan Overview

Part 1

What is the Consolidated Plan (Con Plan)?

- ▶ The State of California's Con Plan is a five-year plan that:
 - ▶ Examines the housing and community development needs of Californians and their communities.
 - ▶ Lays out how federal funds will be used to address the community needs and improve the quality of life for Californians.





Con Plan Overview

Part 2

- ▶ Federal Funding: U.S. Department of Housing and Urban Development (HUD)
- ▶ Enables the State of California to administer funds received from HUD for the following federal housing Community Planning and Development (CPD) formula block grant programs:
 - ▶ Community Development Block Grant (CDBG)
 - ▶ Emergency Solutions Grants (ESG)
 - ▶ HOME Investment Partnerships Program (HOME)
 - ▶ **National Housing Trust Fund (NHTF)**
 - ▶ Housing Opportunities for Persons With AIDS (HOPWA)
 - ▶ CDBG - Disaster Recovery (DR) and Natural Disaster Resilience (NDR)
- ▶ Applicable mainly to “non-entitlement areas” that do not receive funds directly from HUD. These jurisdictions are eligible to participate in HCD-administered programs.



Con Plan Structure

- ▶ **Community Engagement, Consultation, Citizen Participation**
 - Public Participation - Priority Needs identified by the public and our stakeholders.
- ▶ **Needs Assessment**
 - Data Analysis of Housing and Community needs for low and moderate-income residents.
- ▶ **Market Analysis**
 - Data Analysis of Housing Market and Economic Conditions.
- ▶ **Strategic Plan**
 - Priority Needs, Goals, & Resources.
- ▶ **Annual Action Plan**
 - Year 1 Implementation Details.



Community Engagement, Consultation, and Citizen Participation

- ▶ Community outreach and engagement
- ▶ Consultation with public and private agencies to enhance coordination on programs and policies
- ▶ Citizen Participation

Con Plan Submission

- ▶ Upon completion of the Draft Con Plan, HCD posts the document on the website.
- ▶ 30-Day Public Comment Period
- ▶ Public Hearing
- ▶ Upon finalization after public comments are incorporated, HCD submits the plan to BCSH Agency for review.
- ▶ Submission to HUD by May 15, 2025.
