The following manufactured home and mobilehome (MH) alteration and conversion guidelines provide information on HCD's permitting requirements, assists in determining what constitutes an alteration to an MH, and identifies when form HCD MH 415, engineered plans, electrical load calculations, and/or product manufacturer's specifications are required. The table below is divided into four classifications consisting of: electrical, mechanical, plumbing, and structural. If the type of MH alteration work to be performed is not identified, you should contact the nearest area office noted below for further assistance.

**NOTE:** Alteration projects that include multiple elements, such as plumbing, electrical, and structural may be included on the same HCD MH 415 permit application, available at <u>https://www.hcd.ca.gov/manufactured-and-mobilehomes/modifying-mobilehome</u>.
