RE: Los Angeles AB 2097 Implementation –
San Monica Blvd. and Sepulveda Blvd. – Letter of Technical Assistance

This letter provides technical assistance regarding the application of Assembly Bill (AB) 2097 (Chapter 459, Statutes of 2022) and is provided for the benefit of both the City of Los Angeles (City) and Irvine Associates (Requestor)¹. The California Department of Housing and Community Development (HCD) previously issued this letter as an email to the City, sent on January 12, 2024. HCD's Housing Accountability Unit (HAU) received a technical assistance request from the Requestor regarding whether the intersection of Santa Monica Blvd. and Sepulveda Blvd. qualified as a "major transit stop" as defined in the Public Resource Code section 21064.3.

Question 1. Can the Culver City (CC) 6 and 6R colinear local/bus rapid transit (BRT) lines (line family) be combined to meet the 15-minute service interval frequency to qualify as a major transit stop under Public Resources Code section 21064.3, subdivision (c)?

Response. For the purposes of AB 2097, colinear line families are combined and considered as one service route for service interval frequency. Only the locations where the buses stop with a frequency interval of 15 minutes or less during morning and afternoon peak periods may qualify as major transit stops. Line families are intended to function as one bus route, where transit riders typically board the first bus available whether it is a local, express, or BRT line. This determination is consistent with Southern California Association of Governments' (SCAG) Connect SoCal Technical Report, adopted September 3, 2020.² HCD understands, per the City's email response dated January 9, 2024, that the City of Los Angeles is currently considering aligning with SCAG's methodology.

Question 2. Does the intersection of Santa Monica Blvd. and Sepulveda Blvd. qualify as a "major transit stop" as defined in the Public Resources Code section 21064.3?

Response. The Santa Monica Blvd. and Sepulveda Blvd. intersection qualifies as a "major transit stop" because it meets the qualifications of subdivision (c) of Public Resources Code section 21064.3.

A "major transit stop", as defined in the Public Resource Code section 21064.3, means "a site that contains any of the following:

- (a) An existing rail or bus rapid transit station.
- (b) A ferry terminal served by either a bus or rail transit service.
- (c) The intersection of two or more major bus routes with a frequency of service interval of 15 minutes or less during the morning and afternoon peak commute periods."

The Los Angeles (LA) Metro Local Route 4, the Santa Monica Big Blue Bus Route 1, and the CC Lines 6 and 6R each have a bus stop located at the intersection of Santa Monica Blvd. and Sepulveda Blvd. Both the LA Metro Route 4 and CC Line 6 and 6R ("two or more major bus routes") have a frequency of service interval of 15 minutes or less during the morning and afternoon peak commute periods. Table 1 details the average service interval frequency in both directions during the peak periods for LA Metro Route 4 and CC Line 6 and 6R.
