Affordable Housing Goals

 CDBG expended approximately \$5.24 million on acquisition for rehabilitation, single and multi-unit rehabilitation and assistance to low-income homeowners. Approximately \$3 million of this amount was dedicated to first-time homebuyer assistance.

Non-Housing Community Development Goals

 HCD significantly supported rural community development through expenditures on public facilities and infrastructure (approximately \$18.5 million) and public services (approximately \$4.7 million). HCD also supported rural economic development, providing \$4.4 million in assistance to local businesses.

CDBG - Success Story

Memorial Park Grass Valley, County of Nevada



A new basketball court and 2 additional pickleball courts were built, and a turf softball field was installed accommodating many different youth and adult sports including softball for seniors, baseball, soccer, flag football, and kickball. Restrooms were replaced, green spaces were renewed, and access to the park was improved by extending the avenue leading to the park and constructing additional parking.

Project Funding CDBG:

\$3,499,281 + City of Grass Valley PI: \$886,857 = **\$4,386,138 Impact**



CDBG - Success Story

The Odyssey House Adult Residential Program supports clients transitioning to the community from settings including intensive care in psychiatric hospitals, long-term care mental health institutes, or mental health recovery centers. Some clients have experienced chronic homelessness or struggled to live independently prior to admission to Odyssey House, and some have faced additional challenges as they reenter the community from the justice system. The County of Nevada used CDBG funds to renovate the original 1980's dilapidated house into a 6,384 square foot state-of-the-art Transitional Housing Facility for adults experiencing severe mental illness.

CDBG:

\$3,635,507 + County of Nevada CDBG PI: \$437,000 = **\$4,072,507 Impact**

Community Development Block Grant CARES Act (CDBG-CV)





CDBG-CV Program Highlights

- Since launch, CDBG-CV has assisted over 162,000 California residents
- In FY2023, CDBG-CV realized the following accomplishments:
 - Assisted more than 85,000 individuals through public services
 - Supported 50 economic development programs across the State
 - Continued development of 32 permanent housing multi-family developments
 - Created or improved access for more than 30,000 individuals to public facilities across the State
- In FY2023, CBDG-CV expended \$27m on eligible activities



CDBG-CV Program Highlights

- City of Dixon Small Business COVID Support Program
 - Assisted 11 small businesses impacted by COVID 19 to retain jobs through forgivable loans
- City of Paso Robles Homekey Rehabilitation
 - Converted 60 Homekey rooms into studio apartments for households experiencing homelessness
- County of Trinity Health Transportation Services
 - Procured vehicle to transport behavioral health clients to treatment outside of the County; offering this service to over 1,746 clients with 152 clients regularly needing this service

Emergency Solutions Grants (ESG)





ESG - Program Highlights

- During the FY23 Reporting Period, ESG served approximately 17,000 persons and expended over \$9 million dollars.
- > In September of 2023, a Homelessness Prevention NOFA for \$1.7 million in disencumbered funds was issued
 - > 6 subrecipients were awarded over 1 million dollars

- ➤ 49 Subrecipients, including 7 Tribal Communities, had executed contracts to utilize ESG-CV funds to prepare for, prevent and respond to COVID-19.
- > HCD worked with ICF to provide training, technical assistance and support to subrecipients throughout the grant period.
- ➤ The total ESG-CV amount of funds spent by June 30, 2024 was approximately \$318.7 million of the \$319.5 million.

HOME - Program Highlights

- Released a HOME NOFA in January 2024 for approximately \$120 million, which included 2022 and 2023 HUD HOME allocations, and which included a 20% target reservation for Native American Entities. It was over-subscribed, so it appears all available funds will be awarded, mostly to multifamily projects.
- The State HOME Program greatly exceeded its \$2.27 million matching funds obligation, by roughly \$14.2 million.
- HOME Expenditures were over \$27 million.

Parkside Apartments

- Multifamily Rental New Construction Project
- 39 HOME-assisted Units
- Target Population: Family households and Farmworkers
- > Family households and Farmworkers earning up to 60% of Area Median Income
- > 19 One-bedroom apartments, 10 Two-bedroom apartments & 10 Three-bedroom apartments
- On-Site Amenities: leasing office, spacious community room, and maintenance shop
- Shopping, a grocery store, schools, and public transportation are within a mile of the project
- Located in the City of Delano, in Kern County

Housing Opportunities for Persons With AIDS (HOPWA)



HOPWA - Program Highlights

- ► The Housing Opportunities for Persons With AIDS (HOPWA) Program funds housing assistance and supportive services designed to reduce or prevent homelessness for persons living with HIV (PLWH).
- During FY 2023-24, HOPWA served:
 - ▶ 683 households with housing assistance (rent, mortgage, utility, move-in, shelter, facility operating costs)
 - ▶ 810 households with supportive services (food, transportation, case management)
 - ▶ 300 households with housing location and information assistance


